In January 2005, the Assembly held a debate under urgent procedure and adopted Resolution 1420 (2005) on prospects for peace in the Middle East. 18.03.05 - The Bureau asks the Sub-Committee on Middle East to make proposals on the possible organisation of a tripartite forum under Resolution 1420 (2005). June part-session of 2005 - Adoption of Rec. 1707 (2005) and Res. 1452 (2005).

14.03.06 - The Committee held an exchange of views on the basis of a memorandum prepared by the Rapporteur, with the participation of Mr Hasan Khreishe, Vice-President of Palestinian Legislative Council, and of Mr Abdullah Abdullah, member of Palestinian Legislative Council.
