The service 116 111 operates under the consortium of Non-Governmental Organizations, Association for the Prevention and Handling of Violence in the Family (SPAVO) and "Hope for Children" CRC Policy Centre (HFC).

Child Support Line – **1466** operates under the "Hope for Children" CRC Policy Centre to provide psychological, social and legal support to child victims of violence and neglect and their families. The line operates 24/7 and is free of charge. Calls for help will be forwarded to

the organisation's specialized staff, including psychologists, social workers and lawyers, depending on the needs of the people calling.

There is also information about institutions and organisations that can provide victim with necessary help and support irrespective of the type of offense, time when it occurred and whether the crime has been reported or not. The webpage also offers a chat box, where consultation is possible if a person does not want to call the helpline.



Sexual abuse cases or a possibility of a sexual abuse offence are also reported via this number and certain preventive measures can be put in place in order to stop a possible crime. This hotline serves also on mobile phone apps for people with hearing problems.
