of the meeting held at the French National Assembly on 17 March 2006 in Paris, France

1. OPENING OF THE MEETING

Mr van der Linden, President of the Assembly, opened the meeting at 9.30 a.m.

He thanked the French hosts, and in particular Mr Schreiner, Chairperson of the national delegation of France, for their invitation to hold the current meeting of the Standing Committee at the National Assembly in Paris.

2. EXCHANGE OF VIEWS WITH MR JEAN-CLAUDE JUNCKER, PRIME MINISTER OF LUXEMBOURG, ON HIS DRAFT REPORT ON THE RELATIONS BETWEEN THE COUNCIL OF EUROPE AND THE EUROPEAN UNION AS/Bur (2006) 29

Mr Juncker, Prime Minister of Luxembourg, said that he planned to present his report on relations between the Council of Europe and the European Union (EU) at the Parliamentary Assembly session on 11 April 2006. Even though the request for the report had come from the heads of state and government, he had chosen the Parliamentary Assembly for the public presentation of the report because it met regularly and in order to emphasise the leading role of parliaments within democracies. The Assembly was also ideally placed to follow-up the implementation of the report's recommendations.

He would confine himself to presenting the basic principles of his report and recalled that it had been written in his own name. This had offered him a certain flexibility in its drafting. The report would demonstrate the need to retain the Council of Europe as one element of the European institutional landscape with its own instruments, powers and responsibilities, which had to be distinguished from those of the EU.

He believed that co-operation between the Council and the Union should be further developed, on the basis that there would be no competition between the two. Given the scale and quality of the Council's experience in the human rights field, therefore, it should have absolute priority in this area. This meant that the Agency for Fundamental Rights currently being established by the European Union should be confined to the application of Community law in EU member states. Against this background, the Council of Europe's main task would be to assess the human rights situation in non-EU member countries. Depending on circumstances and when the situation required, the Agency could ask the Council to undertake additional assessments, in accordance with its own instruments.

Mr Juncker also thought that the Council of Europe Commissioner for Human Rights should be granted a leading role within the Agency. The Council should also have a seat on the Agency's governing body and should appoint its own representative. As such it would not be considered as an adjunct of the Agency but rather as an integral part of its governing bodies.

Turning to the EU Constitutional Treaty, which provided for Union accession to the European Convention on Human Rights, Mr Juncker said that his report would include proposals that would enable the EU to accede to the Convention via its member states without awaiting ratification of the Treaty.

He thought that the so-called "deconnection clauses" question should be defused and said that his report would make proposals for involving EU member states in the machinery for applying Council conventions and in their actual application in the countries concerned.

There was also scope for improving institutional relations between the two organisations, for example by involving the Council's Secretary General in the Union's "political" activities and by strengthening cooperation between the Parliamentary Assembly and the European Parliament. He would also propose that the EU be authorised to refer matters to the Human Rights Commissioner and that it accede to the partial agreement establishing the European Commission for Democracy through Law, the so-called Venice Commission. More account should also be taken of NGOs and local and regional authorities in the two organisations' activities.

Finally, Mr Juncker pointed out that the Council of Europe was active in areas other than human rights. These included culture, intercultural dialogue, education and youth activities, all of which were essential if Europeans were to learn to live together.

In connection with the two organisations' respective positions on the European political scene, Mr de Puig thought that its membership, its political nature and its geographical scope gave the Council of Europe a specific role that the Union could not replace. Indeed, it could contribute to the Union's neighbourhood policy, since some of the country's concerned, particularly in the Middle East, were direct neighbours of the Council

of Europe. He thought that the Union's Agency for Fundamental Rights would duplicate work being carried out and that, given the existence of the European Court, the Human Rights Commissioner and the Assembly's human rights committee and sub-committee this would simply lead to a waste of resources. Turning finally to the parliamentary dimension, he thought that close co-operation between the Parliamentary Assembly and the European Parliament would also facilitate co-operation between the latter and the national parliaments of Council of Europe member states.

Mr Van den Brande said that EU member states that were also members of the Council of Europe had a dual loyalty. The 25 EU member states must not be allowed to form a bloc within the Council. The former group therefore had a double responsibility. Given the financial problems facing both organisations, they also needed to avoid any duplication of activities. Nevertheless, the Agency for Fundamental Rights could be useful in a clearly defined context, namely that of applying Community law and nothing else. He agreed with Mr de Puig on the EU's neighbourhood policy and encouraged the Union to use Council of Europe instruments and conventions in certain areas. Finally, it was important not to reach any conclusions on the "memorandum of agreement" between the two organisations before the Assembly had had the opportunity to consider it in a written form.

Mr Kosachev said that the debate on relations between the two organisations was important for non-EU member countries. The Union was undoubtedly an effective organisation but only the Council exercised authority right across Europe. The parliamentary dimension should play a key part in the report and the European Union should accede to the European Convention on Human Rights. Finally, he hoped that the Assembly would be able to express its views on the "memorandum of understanding" between the two organisations.

Mrs Severinsen thought that there was a great risk of duplication of activities as regards the Fundamental Rights Agency, given the size of the Agency's operating budget. Tax payers' money should be better used and be concentrated on improving dialogue between Council of Europe member states, particularly by stepping up the monitoring system and intercultural dialogue to supplement the Union's neighbourhood policy.

Mr Kox said that, according to the conclusions of the Third Summit, the Council of Europe had resolved to concentrate on the core values it was pledged to protect, namely democracy, the rule of law and human rights, and on co-operation with the EU. The European Court should not be allocated financial resources at the expense of other Council activities, a point supported by Mr Schreiner.

Mrs Papadimitriou called for the report to give full prominence to the parliamentary dimension and asked whether it was appropriate to base the new agency on the former European Monitoring Centre on Racism and Xenophobia in Vienna.

Mr Legendre was concerned that the new agency might lead to duplication and referred to the current financial difficulties.

Mr Gross proposed EU participation in the financing of the European Court of Human Rights.

Mr Ates called for a division of labour to ensure that the Council and the EU did not compete and grow increasingly remote from each other.

Mr Juncker said that his report would include proposals on how the EU agencies should be organised. Cooperation between the two organisations should be properly structured and he would present proposals on how this co-operation should be financed. However, as far as the European Court was concerned, he invited members of parliament to enter into direct discussions with their national governments about possible additional funding from national budgets, rather than seeking EU financial support. It was illogical to complain about excessive EU influence on Council of Europe decision making and then ask it to finance part of the Council's activities from its own resources.

5. REQUEST FOR A CURRENT AFFAIRS DEBATE

<u>The President</u> said that he had received a request for a current affairs debate on 14 March 2006 signed by Mr Legendre, Chairperson of the Committee on Science, Culture and Education, and some forty others. It concerned freedom of expression and respect for religious beliefs. The Bureau supported the idea of a debate on this topic.

The Standing Committee **approved** the request and noted that the Bureau had appointed Mr Legendre to be first speaker (for the debate itself, see item 10 of the agenda).

The draft agenda was adopted.

7. APPROVAL OF THE MINUTES OF THE PARLIAMENTARY ASSEMBLY'S SITTINGS ON 26 JANUARY (AFTERNOON) AND 27 JANUARY (MORNING) 2006

8. REFERENCES, TRANSMISSIONS AND MODIFICATIONS OF REFERENCES TO COMMITTEES

The Head of the Table Office referred to document AS/Bur (2006) 027 and the proposals agreed by the Bureau in the morning.

The Standing Committee **approved** the references, transmissions and modifications of references as they appeared in Appendix II.

9. OBSERVATION OF ELECTIONS

AS/Bur/AH PAL (2006) 2

Elections to the Palestinian Legislative Council (25 January 2006)

Rapporteur of the Ad Hoc Committee of the Bureau: Lord Russell-Johnston (United Kingdom, ALDE)

<u>Lord Russell-Johnston</u> presented the report on the observation of elections to the Palestinian Legislative Council. Despite worries about possible violence because of the difficult political situation, the elections had been organised and conducted in a democratic fashion.

Mr Kox said that a debate on the situation in the Middle East was scheduled for the April 2006 part-session and that a representative of the Palestinian parliament would be invited to take part.

Mr Ates said that a representative of Hamas should also be invited.

The Standing Committee **took note** of the report.

10. CURRENT AFFAIRS DEBATE

Mr Legendre opened the debate on freedom of expression and respect for religious beliefs. Freedom of expression and thought were at the heart of the Council of Europe's values. They should not try to limit

freedom of the press but adopt a European approach to the problem. For some, their faith was absolute and deliberate violation of it could cause real suffering that might be condemned in the courts. This was the case with the publication of the cartoons in Denmark. Freedom of expression must not be restricted but it might be subject to political manipulation, social disquiet and nationalist fervour.

Mr de Puig agreed that freedom of expression should not be restricted but it also had to be compatible with respect for others. The cartoons did constitute an attack on Muslims but he pointed out that the angry reactions had occurred several months after they appeared.

Mrs Severinsen said that the Danish Prime Minister had condemned the blasphemy but had not prosecuted the newspapers that had published the cartoons. Freedom of expression should always go hand in hand with respect for others. It was therefore essential to resume dialogue but also to guarantee press independence and its right to criticise the authorities, thus enabling it to combat totalitarian religious regimes.

Mr Kox said that absence of censorship underlays freedom of expression but a civilised society was one in which people were not entitled to insult others deliberately. The indignant reactions of those concerned were in large measure a consequence of differences in power and wealth, of which these parts of the world were well aware.

Mrs Papadimitriou also spoke of the need to respect others, which was often governed by unwritten rules, and called on the Council of Europe to draw up instruments to avoid further difficulties, particularly connected with racism, with the Muslim world.

Mr Van de Brande also thought that a balance had to be struck between freedom of expression and respect for others. Freedom of expression was a shared value, despite diversity of opinions.

Mr Çavuşoğlu thought that Denmark should apologise for what had happened. It was supporting the United States in the Iraq war and authorised certain television channels and newspapers that were banned elsewhere. However, Muslims should use democratic methods rather than violence to protest.

Mr Hörster referred to freedom of the press and said that governments should not have to apologise on behalf of the press. This was not a question of a clash of cultures but of protests and violence that were being manipulated by middle eastern countries that lacked legitimacy in the eyes of their people.

<u>The President</u> said that the Committee on Science, Culture and Education would be presenting a report on "blasphemy, religious insults and hate speech against persons on grounds of their religion" and said that he intended to ask the Bureau to refer the subject of this current affairs debate to the Committee.

11. POLITICAL AFFAIRS

Need for international condemnation of the Franco regime

Rapporteur of the Political Affairs Committee: Mr Leo Brincat (Malta, SOC)

Mr Brincat presented the report "Need for international condemnation of the Franco regime", which appeared in Doc. 10737. Franco had operated a totalitarian regime that had committed the most extreme human rights violations. Even though Spain was now a democracy, his report made certain proposals aimed at ensuring that the sacrifices made by the civilian population during this period would never be forgotten.

Mr de Puig said that the aim of the report was to avoid any repetition of the events in Spain and ensure that the reconciliation process that followed the regime's fall would serve as an example.

Mr Kox thought that countries could learn from what had happened in Spain.

Following a vote, the Standing Committee adopted the recommendation as it appeared in Doc. 10737.

12. SOCIAL, HEALTH AND FAMILY AFFAIRS

A dynamic housing policy as an element of European social cohesion

Rapporteur of the Committee on Social, Health and Family Affairs: Mr Denis Jacquat (France, EPP/CD)

Mr Jacquat presented the report "a dynamic housing policy as an element of European social cohesion", which appeared in Doc. 10833. He spoke of the need to reaffirm the right to housing and said that persons with a home integrated more easily into society.

Mrs Cliveti supported the report's conclusions and drew particular attention to poverty among women.

Mr Gardetto said that there was a particular problem in small areas such as his where the housing market was very speculative.

Following a vote, the Standing Committee adopted the resolution as it appeared in Doc. 10833.

13. MIGRATION, REFUGEES AND POPULATION

New trends and challenges for Euro-Mediterranean migration policies

On behalf of Mr Danieli, <u>Mr Çavuşoğlu</u> presented the report on "new trends and challenges for Euro-Mediterranean migration policies", which appeared in Doc. 10763. It called for closer co-operation between the Mediterranean countries to manage migration and a strengthening of the Mediterranean's traditional role as an economic and cultural crossroads.

Following a vote, the Standing Committee adopted the recommendation as it appeared in Doc. 10763.

14. CULTURE, SCIENCE AND EDUCATION

The future and regeneration of coalfields in Europe

Doc. 10825

Rapporteur of the Committee on Social, Health and Family Affairs: Mr Jean-Pierre Kucheida (France, SOC)

Rapporteur of the Committee on Environment, Agriculture Doc. 10845 and Local and Regional Affairs (for opinion):
Mr Bill Etherington (United Kingdom, SOC)

On behalf of Mr Kucheida, <u>Mr Legendre</u> presented the report on "the future and regeneration of coalfields in Europe", which appeared in Doc. 10825. More than 80% of the jobs in the coal mining had disappeared in the space of twenty years and the areas affected needed comprehensive regeneration. He referred to the cultural aspects of the mining industry, including books and films, which constituted a very special heritage.

Mr Etherington presented the opinion of the Committee on Environment, Agriculture and Local and Regional Affairs, which appeared in Doc. 10845. Society as a whole had inherited the knowledge and skills of the mining industry and this heritage must be preserved.

Mrs Cliveti thanked the rapporteur for having taken into account problems affecting women in the report.

Following a vote, the Standing Committee adopted the resolution as it appeared in Doc. 10825.

15. ENVIRONMENT, AGRICULTURE AND LOCAL AND REGIONAL AFFAIRS

Regrouping land in Central and Eastern Europe

Doc. 10836

Rapporteur of the Committee on Environment, Agriculture and Local and Regional Affairs: Mr Theo Maissen (Switzerland, EPP/CD)

In Mr Maissen's absence, Mr Schmied presented the report on "regrouping land in central and eastern Europe", which appeared in Doc. 10836. The agricultural policy had to be modified to allow the owners of small and scattered parcels of farming land to regroup them into larger cultivable tracts, in accordance with prevailing legislation.

Mr Preda said that the report cited a successful pilot project that could serve as an example. He did not think it appropriate to refer to a pilot project with no European ramifications in the resolution and moved an oral amendment to delete paragraph 8 of the draft resolution.

Following a vote, the oral amendment was rejected.

Following a further vote, the Standing Committee adopted the resolution as it appeared in Doc.10836.

16. EQUAL OPPORTUNITIES FOR WOMEN AND MEN

a. Mechanisms to ensure women's participation in decision-making

Doc. 10743

Rapporteur of the Committee on Equal Opportunities for women and men: Mrs Minodora Cliveti (Romania, SOC)

Rapporteur of the Committee on Rules of Procedure and Immunities (for opinion):

Mrs Ana Catarina Mendonça (Portugal, SOC)

Doc. 10846

Mrs Cliveti presented the report on "mechanisms to ensure women's participation in decision-making", which appeared in Doc. 10743. She criticised the fairly low percentage of women members of parliament at national and international levels and called for more sharing of responsibilities between women and men.

Mrs Mendonça presented the opinion of the Committee on Rules of Procedure and Immunities, which appeared in Doc. 10846 and she said that certain proposals in the report raised procedural problems.

<u>Mr Schreiner</u> called for a family policy that gave women the opportunity and time to become more involved in politics and society.

Mrs Mendonça presented an amendment to replace paragraphs 8.2 and 8.3 with a single paragraph. Following a vote, the amendment was **adopted**.

Following a further vote, the Standing Committee **adopted** the modified resolution and the recommendation as they appeared in Doc. 10743.

b. Gender budgeting

In Mrs Čurdová's absence, Mrs Cliveti presented the report on "gender budgeting", which appeared in Doc. 10764. Such budgets would not only offer women more financial resources but also ensure that income and expenditure were restructured to promote equality between the sexes.

Mr Schmied said that the current trend was towards harmonising budgets and treating the two sexes equally whereas this report pointed towards a separate assessment of women's and men's needs.

Following a vote, the Standing Committee **adopted** the recommendation as it appeared in Doc. 10764.

17. RULES OF PROCEDURE AND IMMUNITIES

a. Interpretation of Article 15.a of the General Agreement on Privileges and Immunities of the Council of Europe Doc.

On behalf of Mr Jurgens, Mr Gross presented the report on "interpretation of Article 15.a of the General Agreement on Privileges and Immunities of the Council of Europe", which appeared in Doc. 10840. Henceforth, the correct interpretation was that Council of Europe immunity would apply when members were exercising their functions as Assembly members or when travelling on Assembly business, whether inside or outside their national territory. If they were not active within this meaning or not travelling on Assembly business, the national regime would apply.

Following a vote, the Standing Committee adopted the resolution as it appeared in Doc. 10840.

b. Inclusion in the Assembly's Rules of Procedure of a new rule on co-operation with the European Parliament

Rapporteur of the Committee on Rules of Procedure and Immunities: Mr Erol Aslan Cebeci (Turkey, EPP/CD)

Mr Cebeci presented the report on "inclusion in the Assembly's Rules of Procedure of a new rule on cooperation with the European Parliament", which appeared in Doc. 10784. For years, the European Parliament had had a specific rule on co-operation with the Parliamentary Assembly. The reason for including such a rule in the Assembly's Rules of Procedure was to encourage co-operation with committees of the Parliament in areas of common interest and offer Assembly bodies a certain clarity and flexibility in their activities.

Following a vote, the Standing Committee adopted the resolution as it appeared in Doc. 10784.
