Synopsis of the meeting held in Paris on 12 March 2018

The **Committee on Political Affairs and Democracy**, meeting in Paris on 12 March 2018 with Ms Ria Oomen-Ruijten (Netherlands, EPP/CD) in the Chair, as regards:

- Implementation of budgetary savings within the Assembly following the decisions by the Bureau: heard a statement by the Chairperson, and decided to revert to the issue at its next meeting;
- Open discussion on current issues: heard a statement by the Chairperson on the recent flare-up of
 tension between Turkey and the Republic of Cyprus and between Turkey and Greece, following
 incidents involving the Turkish Navy in the Exclusive Economic Zone of Cyprus in the Eastern
 Mediterranean and in the Greek territorial waters in the Aegean Sea, and, following an exchange of
 views, asked the Chairperson to write in this respect to the Secretary General of the Council of
 Europe;
- Protecting and supporting the victims of terrorism (Rapporteur: Ms Marietta Karamanli, France, SOC): heard a statement by the Rapporteur, followed by an exchange of views;
- The situation in Syria and its effects upon surrounding countries (Rapporteur: Ms Theodora Bakoyannis, Greece, EPP/CD): heard a statement by the Rapporteur followed by a hearing with the participation of Mr Eugenio Dacrema, Research fellow Middle East and Northern Africa, Italian Institute for international political studies (ISPI);
- Assessing political consequences of foreign funding of Islam in Europe (Rapporteur: Ms Doris Fiala, Switzerland, ALDE): heard a statement by the Rapporteur and considered an introductory memorandum;
- The situation in Libya: prospects and role of the Council of Europe (Rapporteur: Mr Attila Korodi, Romania, EPP/CD): approved a report and unanimously adopted a draft resolution and a draft recommendation:
- The evaluation of the partnership for democracy in respect of the Parliament of Morocco (Rapporteur: Mr Bogdan Klich, Poland, EPP/CD): heard a statement by the Rapporteur on his factfinding visit to Rabat from 5 to 8 February 2018;
- Identity, role and mission of the Parliamentary Assembly as a statutory organ of the Council of Europe, and a pan-European forum for inter-parliamentary dialogue (Rapporteur: Mr Tiny Kox, Netherlands, UEL): heard a statement by the Rapporteur, took note of the reply of the Committee of Ministers to Recommendations 2113 and 2114 (2017) and decided to change the title to Role and mission of the Parliamentary Assembly: main challenges for the future;

- Appointment of Rapporteur: appointed Mr Frithjof Schmidt (Germany, SOC) for report on Democracy hacked? How to respond? and heard from him a declaration of absence of any conflict of interest;
- Authorisations by the Committee: authorised:
 - Mr Ervin Bushati (Albania, SOC), Rapporteur on The activities of the Organisation for Economic Co-operation and Development (OECD) in 2018-2019, to participate in the OECD Global Parliamentary Network Meeting on Inclusive Growth (London, United Kingdom, 4-5 April 2018), subject to availability of funds;
 - Ms Marietta Karamanli (France, SOC), Rapporteur on Protecting and supporting the victims of terrorism, to carry out fact-finding visits to Spain and the United Kingdom, subject to availability of funds;
- Changes in the composition of the Sub-Committees: approved the following changes:
 - Sub-Committee on External Relations
 - Mr Filippo Lombardi (Switzerland, EPP/CD) becomes alternate of Ms Elisabeth Schneider-Schneiter (EPP/CD),
 - Sub-Committee on relations with the OECD and the EBRD
 - Mr Andres Nick (Germany, EPP/CD) becomes full member instead of alternate to Ms Doris Barnett (SOC),
 - Ms Didem Engin (Turkey, SOC) becomes alternate to Mr Deniz Baykal (SOC), instead of Mr Cemalettin Kani Torun (EC);
- Other business: welcomed the invitation by Ms Sanja Putica, Chairperson of the Croatian delegation, to co-organise, in Dubrovnik, on 6 November 2018, a conference on *Building democratic security in the Mediterranean: Common challenges, Shared responsibility*, in the framework of the Croatian Chairmanship of the Committee of Ministers (subject to the authorisation by the Bureau);
