Synopsis of the meetings held in a hybrid manner from 27 to 30 September 2021

The **Committee on Political Affairs and Democracy**, meeting in a hybrid manner from 27 to 30 September 2021, with Mr Zsolt Németh (Hungary, EC/DA), Chairperson, in the Chair:

- On Monday 27 September 2021 at 2pm, as regards:
- The situation in Afghanistan: consequences for Europe and the region:
 - . held a hearing organised with the contribution of the Committee on Migration, Refugees and Displaced Persons, with the participation of Ms Mette Knudsen, Deputy Special Representative of the UN Secretary-General for Afghanistan, United Nations Assistance Mission in Afghanistan (UNAMA); Ambassador Zamir Kabulov, Presidential Envoy to Afghanistan, Russian Federation; Ms Laurel Miller, Programme Director for Asia, International Crisis Group; and Mr Alexander Mundt, Senior Policy Advisor, Office of the United Nations High Commissioner for Refugees (UNHCR);
 - . appointed, by acclamation, Sir Tony Lloyd (United Kingdom, SOC) Rapporteur and heard from him a declaration of absence of conflict of interests;
- On Tuesday 28 September 2021 at 8.30am, as regards:
- Debate under urgent procedure: The situation in Afghanistan: consequences for Europe and the region (Rapporteur: Sir Tony Lloyd, United Kingdom, SOC): considered a draft report and unanimously adopted a draft resolution as amended;
- More participatory democracy to tackle climate change (*Rapporteur: Mr George Papandreou*, Greece, SOC): took note that no amendments had been tabled to the draft resolution and the draft recommendation;
- Call for an inclusive national political process in Belarus (*Rapporteur: Mr Kimmo Kiljunen, Finland, SOC*): heard a statement by the Rapporteur on recent developments and his fact-finding visit to meet relevant Belarusian political stakeholders living abroad, in Vilnius (Lithuania) on 1st and 2 September and in Warsaw (Poland) on 2 and 3 September 2021; took note of the motion for a resolution on "Belarus state terrorism as a threat to the whole of Europe" (Doc. 15319) and the current affairs debate on "The situation in Belarus: a threat to the whole of Europe", held during the June part-session 2021, to be taken into account in the preparation of the report;

- Preparation of the Committee meeting on 3 and 4 November 2021 in Budapest: heard a statement by the Chairperson and took note of the draft programme and practical information;
- On Wednesday 29 September 2021 at 2pm, as regards:
- The situation in Tunisia: held a hearing with the participation of Mr Gianni Buquicchio, President of the European Commission for Democracy through Law (Venice Commission); Ms Sophie Bessis, Historian and political scientist, specialist in the Maghreb; and Ms Pilar Morales Fernández-Shaw, Coordinator of the Neighbourhood Policy with the Southern Mediterranean, Head of the Council of Europe Office in Tunis; considered and unanimously adopted a motion for a resolution on the "Political situation in Tunisia" to be tabled on its behalf; appointed (pending reference of the motion to the Committee) Mr Claude Kern (France, ALDE) Rapporteur and heard from him a declaration of absence of conflict of interests;
- The Western Balkans between democratic challenges and European aspirations: what role for the Council of Europe?: held an exchange of views; appointed, following a vote, Mr George Papandreou (Greece, SOC) Rapporteur on "Supporting a European perspective for the Western Balkans" and heard from him a declaration of absence of conflict of interests;
- On Thursday 30 September 2021 at 8.30am, as regards:
- Debate under urgent procedure: The situation in Afghanistan: consequences for Europe and the region: (*Rapporteur: Sir Tony Lloyd, United Kingdom, SOC*): took position on 6 amendments and 2 oral sub-amendments to the draft resolution;
- First Global Parliamentary Summit on Counter-Terrorism: heard a statement by Ms Marietta Karamanli (France, SOC), former Rapporteur on "Protecting and supporting the victims of terrorism", on her participation in the Summit on 9 September 2021 in Vienna, Austria;
- Changes in the composition of Sub-Committees: approved the following change:

Ms Marina Carobbio Guscetti (Switzerland, SOC) becomes alternate to Ms Marianne Maret (Switzerland, EPP/CD) in the Sub-Committee on External Relations;

Other business:

- . heard a statement by Ms Ria Oomen-Ruijten (Netherlands, EPP/CD), Chairperson of the Sub-Committee on External Relations, on a possible meeting of the Sub-Committee in New York (United States of America) on 22-23 November 2021;
- . heard a statement by Mr Anuarbek Akhmetou (Republic of Kazakhstan);
