Synopsis of the meeting held in Paris in a hybrid manner on 6 December 2021

The **Committee on Political Affairs and Democracy**, meeting in Paris in a hybrid manner on 6 December 2021, with first Mr Andreas Nick (Germany, EPP/CD), first Vice-Chairperson, and then Mr Claude Kern (France, ALDE), third Vice-Chairperson, in the Chair, as regards:

- The impact of Brexit on Human Rights on the island of Ireland (*Rapporteur: Mr George Katrougalos, Greece, UEL*): held a hearing with the participation of Ms Alyson Kilpatrick, Chief Commissioner of the Northern Ireland Human Rights Commission, and Mr Daithí Ó Ceallaigh, Director General of the Institute of International and European Affairs (IIEA), Ireland;
- Strengthening the role of the Council of Europe as a cornerstone of the European political architecture (*Rapporteur: Mr Andreas Nick, Germany, EPP/CD*): held a hearing with the participation of Mr Gerald Knaus, Chairperson, European Stability Initiative, and Mr Fuat Keyman, Director, Istanbul Policy Center;
- Geopolitics of the Mediterranean: held a hearing with the participation of Admiral Pascal Ausseur, Director General, Mediterranean Foundation of Strategic Studies, Toulon (France);
- Fostering healthy democracies in Europe (Rapporteur: Ms Marie-Christine Dalloz, France, EPP/CD): considered a preliminary draft report;
- Protecting the pillars of democracy during health crises (*Rapporteur: Ms Marietta Karamanli, France, SOC*): heard a statement by the Rapporteur followed by an exchange of views and took note that an introductory memorandum would be sent to members for written comments;
- Establishment of a "youth partner" status with the Parliamentary Assembly (*Rapporteur: Mr Anastasios Chatzivasileiou, Greece, EPP/CD*): heard a statement by the Rapporteur followed by an exchange of views;
- Call for an inclusive national political process in Belarus (*Rapporteur: Mr Kimmo Kiljunen, Finland, SOC*): heard a statement by the Rapporteur followed by an exchange of views; expressed broad support for the Rapporteur's proposal to hold a hearing on constitutional reform in Belarus during the January 2022 part-session with the participation of a representative of the Venice Commission, a representative of the Belarusian authorities and a representative of the Belarusian opposition and asked the Rapporteur to explore, with the potential participants, the feasibility of holding such a hearing; furthermore, asked the Rapporteur to explore the feasibility of holding a hearing on an inclusive national political process in Belarus at a later stage, with the participation of representatives of the Belarusian parliament and of the opposition, and to come back to the Committee with a proposal;
- Establishment of Sub-Committees in 2022: considered a memorandum prepared by the Secretariat under the instructions of the Chairperson; agreed to the proposal to reconstitute, during the January 2022 part-session, the Sub-Committee on the Middle East and the Arab World and the Sub-Committee on External Relations and to constitute a new Sub-Committee on Democracy; and invited members to send, via their delegation secretaries, candidacies for all Sub-Committees by the deadline to be set by the Table Office;
