Synopsis of the meeting held in a hybrid manner on 16 March 2022

The **Committee on Political Affairs and Democracy**, meeting in a hybrid manner on 16 March 2022, with first Mr Zsolt Németh (Hungary, EC/DA), Chairperson, and then Mr Kimmo Kiljunen (Finland, SOC), 1st Vice-Chairperson, in the Chair, as regards:

- Fostering healthy democracies in Europe (*Rapporteur: Ms Marie-Christine Dalloz, France, EPP/CD*): considered a draft report, agreed to a proposal by the Rapporteur to change the title of the report to *Safeguarding and promoting genuine democracy in Europe* and unanimously adopted a draft resolution as amended and a draft recommendation;
- Beyond the Lisbon treaty: strengthening the strategic partnership between the Council of Europe and the European Union (*Rapporteur: Mr Titus Corlăţean, Romania, SOC*): heard a statement by the Rapporteur on his fact-finding visit to European Union institutions on 23-24 February 2022 and considered a preliminary draft report;
- The impact of Brexit on human rights on the island of Ireland (*Rapporteur: Mr George Katrougalos, Greece, UEL*): heard a statement by the Rapporteur on his fact-finding visits to Dublin on 23 February 2022, Belfast on 24-25 February 2022 and London on 28 February 2022, and considered a revised introductory memorandum;
- Call for Famagusta's return to its lawful inhabitants (*Rapporteur: Mr Piero Fassino, Italy, SOC*): heard a statement by the Rapporteur, held an exchange of views on the basis of an introductory memorandum and agreed to the request by the Rapporteur to carry out fact-finding visits to Athens and Ankara in addition to an already authorised visit to Cyprus (subject to the availability of funds);
- The need for renewed, effective and inclusive multilateralism (*Rapporteur: Ms Dora Bakoyannis, Greece, EPP/CD*): heard a statement by the Rapporteur, took note of her proposal to invite the Presidents of the Parliamentary Assembly of the Council of Europe and of the OSCE Parliamentary Assembly for a discussion on this issue to be organised during the meeting of the Committee in Chania, Crete (Greece) on 16-17 May 2022, and held an exchange of views;
- The challenge of far-right ideology to democracy and human rights in Europe (*Rapporteur: Mr Samad Seyidov, Azerbaijan, EC/DA*): heard a statement by the Rapporteur and held an exchange of views;
- Protecting the pillars of democracy during health crises (*Rapporteur: Ms Marietta Karamanli, France, SOC*): heard a statement by the Rapporteur and held an exchange of views;
- **Call for an inclusive national political process in Belarus** (*Rapporteur: Mr Kimmo Kiljunen, Finland, SOC*): heard a statement by the Rapporteur;
- Meeting of the OECD Global Parliamentary Network (Paris on 17-18 March 2022): appointed Ms Isabel Meirelles (Portugal, EPP/CD) as a member of the ad hoc Sub-Committee;
