## The Need to conclude the WTO Doha Development Agenda in 2006

Motion for a resolution presented by Mr Sasi and others

This motion has not been discussed in the Assembly and commits only the members who have signed it

1. The Ministerial Conference of the World Trade Organisation (WTO) held in Hong Kong in December 2005 made progress on the road toward a successful conclusion of the Doha Development Agenda by the end of 2006. Success by that time would open trade and establish more balanced and fair rules for it. This would boost economic growth and ensure improved living standards and reduce poverty in developing countries.

2. A closer look at the Hong Kong Agreement, however, reveals how limited progress in fact was. Some cornerstones were placed, such as the end date for agricultural export subsidies. With so little time remaining and so much work ahead, it is vital that WTO members now move forward with new resolve and a preparedness to make the necessary compromises.

3. Dialogue and parliamentary support in this endeavour is highly important, as was shown in the Hong Kong Session of the Parliamentary Conference on the WTO held in conjunction with the WTO Ministerial meeting. The Parliamentary Conference, in which the Parliamentary Assembly took an active part, worked in close symbiosis with the Ministerial Conference, reiterating its view that "the days when trade policy was the exclusive domain of the executive branch are over" and that it is "resolved to play a far greater role in overseeing WTO activities and promoting the fairness of the trade liberalisation process". Parliaments – whether at national, European or worldwide level – must press governments not to lose momentum and time, and to take on board parliamentary concerns even more than so far.

4. Council of Europe countries have much to gain from negotiations. Decisions concerning agricultural subsidies, customs tariffs, trade in services, intellectual property rights and trade facilitation are stepping stones for enhanced prosperity and employment in Europe.
