Re: Election of Judges for the European Court of Human Rights – List of Candidates in respect of Cyprus

With reference to your letter dated 29 June 2007 (ref.: DG-HL/PB/NS/rs/189-07), I would like to inform you that the Government of Cyprus, following the decision of the Bureaux of the Parliamentary Assembly, has repeated the whole procedure for selecting a new list of candidates for the election of a judge in respect of Cyprus to the European Court of Human Rights.

Let me from the outset inform you that my Government has done its utmost to heed the call of the Assembly and submit a new list of candidates according to the established procedure. Despite the small size of our country, something that undoubtedly affects the availability of able candidates, the procedure followed fully satisfied the criteria of transparency, fairness and openness. Moreover, in drawing up the national list of candidates, all efforts were made to satisfy the criterion for a balanced representation of women and men, especially encouraging female candidates with the necessary human rights experience to apply. Unfortunately, despite all our efforts only one female candidate applied for the position.

The procedure followed for the selection of candidates was as follows:

 the call for candidates was published anew in the Official Gazette of the Republic of Cyprus;

- the Attorney General addressed a letter to all Lawyers employed in the civil service in Cyprus and to the Cyprus Bar Association, informing them of the vacancy and calling on all interested persons to apply;
- the President of the Supreme Court issued a circular addressed to all Judges, informing them of the opening and calling on interested judges to apply. Parallel to this, the list of qualifications and job description was also distributed.

Upon expiration of the set deadline, a meeting of the quadripartite Committee responsible for selecting the candidates was convened (comprised of the Minister of Foreign Affairs as Chairperson, the Minister of Justice and Public Order, the Attorney-General and the President of the Supreme Court). The Committee studied the applications received and decided to nominate the following candidates:

1. Mr. George Nicolaou

Judge of the Supreme Court of Cyprus.

2. Ms. Elena Efrem

District Court Judge - Assize Court of Nicosia.

3. Dr. George A. Serghides

President of the Family Court for the districts of Nicosia and Kyrenia.

The curricula vitae of the above candidates are attached to this letter.

As you can see, our current list is modified with the inclusion of a new candidate. This is due to the fact that despite all our efforts, not many interested and qualified candidates applied for the position. In particular, only two new applications were received.

Nonetheless, we are of the opinion that the three candidates presented are eminent jurists, thus satisfying the criteria laid down in Article 21, paragraph 1, of the Convention. It is our firm belief that the current list will be transmitted to the Parliamentary Assembly as soon as possible, so as to be able to hold the election of the Cyprus judge during the October 2007 session (1-5 October).

IV. Activities and experience in the field of human rights

The provisions of the European Convention on Human Rights are applicable by the Cyprus Family Court. Law 39/62 ratifies the said Convention in Cyprus and since 1962 it forms an internal part of the Cyprus law, having a superior force over ordinary legislation. The following articles of the Convention are the most relevant in my field: article 6 (right of a fair trial), article 8 (right to respect for private and family life), article 9 (freedom of religion), article 12 (right to marry), article 14 (prohibition of discrimination) and article 1 of Protocol 1 (protection of property).

As a former lawyer

I have dealt with many issues on human rights, especially property rights in compulsory acquisition cases and street-widening cases.

As a writer

All three of my doctorate theses are dealing with human rights, the first (in English) and the third (in Greek) dealing especially with the right to respect for private and family life, freedom of religion, right to marry and prohibition of discrimination and the second (in Greek) dealing especially with the right of property and the principle of proportionality. My Studies in Cyprus Law, vol. 1 (in English), 3 (in English), 4 (in Greek), 5-6 (in Greek) are relevant to the above human rights, respectively. Study No 4, which is in fact a publication of my second doctorate thesis, attributes a whole chapter on article 1 of Protocol 1 (pp. 54-114). On religious freedom, I published three works in Greek: (a) "Religious Freedom, Use and Misuse" in A' European Conference on Sectarianism, Limassol, 2000 pp. 79-100, under the editorship of then Archimandrite Chr. Tsiakkas, (b) "Religious Freedom under Article 9 of ECHR" in Legal Periodical "Tekmirioris", 1098, issue 1, year 1, Jan.-June, pp. 8-11, and (c) "Violations of Constitutional Civil Liberties by Sects and Parareligious Groups", in book, titled "Destructive Sects in the Light of Ortodoxy and their Legal Confrontation", Limassol, 1996, pp. 243-271, published by the Pancyprian Parents Union under the editorship of then Archimandrite Chr.
