On 3 September 2021, Mr Arkadiusz Mularczyk and 23 members of the Assembly requested that the Assembly holds a debate under urgent procedure on:

- Increased migration pressure on the borders of Latvia, Lithuania and Poland with Belarus

Draft decisions:
