The five political groups requested that the Assembly holds an urgent debate on "Consequences of the Russian Federation's aggression against Ukraine"

On 10 March 2022, the Committee of Ministers examining the consequences of the aggression of the Russian Federation against Ukraine, "agreed to consult the Parliamentary Assembly on potential further use of Article 8 of the Statute of the Council of Europe which reads as follows "Any member of the Council of Europe which has seriously violated Article 3 may be suspended from its right of representation and requested by the Committee of Ministers to withdraw under Article 7. If such member does not comply with this request, the Committee may decide that it has ceased to be a member of the Council from such date as the Committee may determine"

Draft decision: to recommend to the Assembly to hold a debate on "Consequences of the Russian Federation's aggression against Ukraine" and to consider an Opinion for the Committee of Ministers within the framework of a consultation under Statutory Resolution (51) 30
