## **PSM role and remit**

- Made for the PUBLIC, financed by the PUBLIC, controlled by the PUBLIC
- Serves the interest of the public as citizens not as consumers
- Foster democratic debate
- Underpin media freedom and pluralism
- Support social cohesion
- Contribute to Europe's cultural diversity

#### **PSM governance – framework of rules and practices**

- Legal framework
- Governing bodies
- Way the legal framework is implemented
- How actors behave within the framework
- Relationship with audiences, public authorities, civil sector





#### **Independence**

- Securing independence is the primary role of framework of PSM governance
- Without independence PSM cannot sustain or gain credibility
- Fundamental requirement is that the editorial autonomy of PSM is guaranteed
- Independence depends on variety of legal, political and cultural factors – political and social structures, culture, interactions





### **Independence II**

- Regulatory and policy framework sets out responsibilities of government, parliament, regulator, PSM, civil society
- Funding should not be used to exert editorial influence or threaten institutional autonomy; PSM is consulted
- Clear criteria for appointments/dismissals should be defined
- Appointments/dismissals should not be used to exert political pressure on PSM





### **European standards**

- The role of PSM is linked to European values and fundamental freedoms
- PSM should serve as an institutional guarantee for media freedom and pluralism
- Council of Europe CM/Rec )(96) 10 on "Independence of Public service media"; CoE CM/Rec N (2007)3; N (2012) 1
- EBU PSM core values independence, universality, diversity, accountability, innovation, excellence
- EBU editorial principles impartiality-independence; fairness-respect; accuracy-relevance; connected-accoverence

#### **Role of Parliaments**

- Adopt appropriate PSM legal frameworks
- Foster debate on Freedom of media
- Elect PSM governing bodies (Serbia, exception)
- Respect PSM institutional and editorial independence







FOR YOUR RIGHTS: TOWARDS EUROPEAN STANDARDS

#### Key points

- Changes in PSM Laws should be based on appropriate assessment
- There should be a broad public debate including PSM
- Engagement of external expertise helps the process CoE, EC, EBU, OSCE





FOR YOUR RIGHTS: TOWARDS EUROPEAN STANDARDS

### **Challenges**

- Understanding of PSM role and remit
- Political will, commitment
- Implementation of Law
- Public debate proper analysis, empirical data
- Ensuring sufficient legal safeguards on PSM independence
- Harmonization with other laws consistency
- PSM governance is not undermined by parallel or overlapping accountability mechanisms

# **Challenges II**

- PSM employees to be exempted from the list of civil servants
- Election and dismissal of PSM governing bodies
- Professionalisation of PSM governing bodies
- Clear separation of supervisory and executive powers
- Accountability
- Independent, stable, predictable and adequate funding
- COVID 19 impact





FOR YOUR RIGHTS: TOWARDS EUROPEAN STANDARDS

### **Clear separation of supervisory and executive powers**

- Supervisory board sets strategic priorities, controls how the remit is fulfilled and elects top management
- The management manages the day-to-day work and has ultimate responsibility for programming and management

- Management should duly inform the Council
