BACKGROUND

The Parliamentary Assembly's Resolution 1823 (2011) calls for adequate parliamentary procedures to verify the compatibility of draft national legislation with the standards of the European Convention on Human Rights (ECHR), the supervision of Strasbourg Court judgments and the provision of relevant human rights awareness-raising activities for parliamentarians and training for the staff of national parliaments.

As from 2012, the Parliamentary Assembly of the Council of Europe (PACE) has held a series of seminars for parliamentarians and staff of member States in order to improve their knowledge of the ECHR system and of the case-law of the European Court of Human Rights (ECtHR), in view of States legal duty to implement the Court's judgments. Five parliamentary conferences and five seminars for the staff of national parliaments were held between 2013 and 2019. A first webinar for the staff was organised in 2020, in an online accessible toolkit format due to COVID 19 travel restrictions.

The present webConference, addressed to parliamentarians from Albania, Bosnia and Herzegovina, North Macedonia and Serbia, is organised in order to:

- strengthen their practical knowledge of relevant provisions of the ECHR and the Strasbourg Court's case-law and the need for national legislation to comply with these standards;
- better inform them of the structure and functioning of the ECtHR;
- increase their awareness of the role of national parliaments in the execution of judgments of the ECtHR;
- > support their efforts in the creation and/or reinforcement of specific structures (committees, subcommittees, legal affairs divisions, etc.) dealing with human rights and/or execution of the ECtHR judgments within national parliaments on regular basis.

In this way, national parliaments strengthen their role to systematically apply the standards of the Convention in national legislation and exercise their role in the control of the executive, particularly with regard to the effective execution of the Court's judgments.

The Handbook "National parliaments as guarantors of human rights in Europe" is currently available online in English, French, Albanian, Bosnian, Croatian, Macedonian, Serbian, among other languages, and will serve as a very useful instrument providing practical solutions for national parliaments to fulfil obligations to guarantee human rights.

This webConference is part of the Action "PACE co-operation with parliamentary assemblies with a view to achieving legislative improvements", funded by the European Union and the Council of Europe and implemented by the Council of Europe under the Horizontal Facility Phase II. The PACE Action will concentrate on the co-operation with the Parliaments of Albania, Bosnia and Herzegovina, North Macedonia and Serbia to support legislative improvements with a view to facilitating the execution of the European Court of Human Rights judgments.
