Secretariat of the Assembly Synopsis 27 May 2014

The **Standing Committee**, meeting on 23 May 2014 in Baku, with Ms Anne Brasseur, President of the Assembly, and then with Ms Doris Fiala, Vice-President of the Assembly, in the Chair:

- heard a welcome address by Mr Ogtay Asadov, Speaker of the Milli Maclis, and held an exchange of views with Mr Elmar Mammadyarov, Minister of Foreign Affairs of the Republic of Azerbaijan, Chairperson of the Committee of Ministers of the Council of Europe;
- ratified the credentials of new members of the Assembly submitted by the delegations of Armenia, France, Germany and Serbia;
- approved changes in the composition of Assembly committees;
- took note of the draft agenda of the third part-session of the Assembly (23-27 June 2014);
- ratified the references proposed by the Bureau which are contained in the Appendix 1 hereafter;
- took note of the report of the Ad hoc Committee of the Bureau on the "Observation of the early parliamentary elections in Serbia (16 March 2014)";
- adopted the following texts on behalf of the Assembly:
