Synopsis

26 May 2015

The **Standing Committee**, meeting on 22 May 2015 in Sarajevo, with Ms Anne Brasseur, President of the Assembly, and then with Mr René Rouquet, Vice-President of the Assembly, in the Chair:

- heard welcome addresses by Mr Šefik Džaferović, Speaker of the House of Representatives and Mr Bariša Čolak, Speaker of the House of Peoples, and held an exchange of views with Mr Igor Crnadak, Minister for Foreign Affairs of Bosnia and Herzegovina, Chairperson of the Committee of Ministers;
- ratified the credentials of new members of the Assembly submitted by the delegations of Germany and Montenegro;
- approved changes in the composition of Assembly committees;
- took note of the draft agenda of the third part-session of the Assembly (22-26 June 2015);
- ratified the references proposed by the Bureau which are contained in the Appendix I hereafter;
- held a current affairs debate on "The situation in 'the former Yugoslav Republic of Macedonia'";
- adopted the following texts on behalf of the Assembly:
