Synopsis of the meeting held in Nicosia on 25 November 2016

The **Standing Committee**, meeting on 25 November 2016 in Nicosia, with Mr Pedro Agramunt, President of the Assembly, and then with Sir Roger Gale, Vice-President of the Assembly, in the Chair:

- heard a welcome address by Mr Demetris Syllouris, President of the House of Representatives of Cyprus, and held an exchange of views with Mr Ioannis Kasoulides, Minister for Foreign Affairs of Cyprus, Chairperson of the Committee of Ministers of the Council of Europe;
- ratified the credentials of new members of the Assembly submitted by the delegations of Andorra and Spain;
- approved changes in the composition of Assembly committees;
- took note of the draft agenda of the first part-session of the Assembly (23 27 January 2017);
- ratified the references which are contained in the Appendix I hereafter;
- adopted the "Declaration of Nicosia: Call for an inclusive constituent process to tackle today's challenges";
- took note of the reports of the Ad hoc Committees of the Bureau on the:
