Organised by the PACE Committee on Migration, Refugees and Displaced Persons, in cooperation with the Council of Europe Youth Department, this will function like a traditional library, that is to say "readers" (PACE members, CoE staff members, all people with access to the Palais) can borrow "books" for a specified period. The only difference with a Living Library is that the "books" are human beings who can share their experiences about the subject with "readers".
