# Communication by the Secretary General of the Parliamentary Assembly at the 1422<sup>nd</sup> meeting of the Ministers' Deputies<sup>1</sup> (19 January 2022)

# I. <u>Decisions taken by the Bureau on 25 November 2021, 10 December 2021 and 14</u> January 2022

# A. First part-session of 2022 (24-28 January 2022)

On 25 November 2021, the Bureau drew up the draft agenda of the first part of the 2022 Assembly's Ordinary Session (appendix 1) and agreed to hold it in a hybrid manner. The draft agenda includes important and topical reports addressing, inter alia, the role of media in times in crisis; combating rising hate against LGBTI people in Europe; the poisoning of Alexei Navalny; football governance; and child participation. Mr Željko Komšić, Chairperson of the Presidency of Bosnia and Herzegovina, will address Assembly members in the context of the 20<sup>th</sup> anniversary of Bosnia and Herzegovina's membership in the Organisation. Communication from the Secretary General of the Council of Europe and from the Committee of Ministers' presidency are also among the key highlights of the part-session. A special ceremony, co-organised with the French authorities, marking the International Day of Commemoration in memory of the victims of the Holocaust will take place on 27 January. The focus of this event will be on "Testimony, memory, teaching, and history: remembrance of the Holocaust for future generations".

The Presidents of the Assembly's five political groups are considering proposing an urgent affairs debate, focusing, in particular on global equitable distribution of vaccines, sufficient vaccine uptake in member States, including the question of mandatory vaccinations, building up stronger health systems to tackle the crisis and stronger commitment to addressing the socio-economic issues that have arisen due to the pandemic.

# Provisions regarding access to the Council of Europe and other health and safety measures in place

On 14 January 2021, the Bureau approved the organisational arrangements of the 2022 January part-session (including the health and safety measures to be put in place to cope with the rapid circulation of the Omicron variant of covid19). In particular, the Bureau:

- confirmed that the part-session would be organised in a hybrid manner, which allows all members of the Assembly to participate in the plenary sittings and committee meetings, either in physical presence or by videoconference;
- in the light of the current sanitary situation, agreed to the physical presence of
  - Current/outgoing President and incoming President of the Assembly;
  - Current/outgoing and incoming Vice-Presidents of the Assembly;
  - Current/outgoing and incoming chairpersons of committees;
  - Presidents of political groups and one female Vice-president per group;
  - Rapporteurs whose reports appear on the agenda of the part-session;
  - Chairpersons of national delegations, and one Vice-chairperson or another member of the delegation not belonging to the ruling majority, who can be accompanied by one secretary of delegation;
- took note of the sanitary protocol which requires, in particular, all participants to fill in the Council of Europe "covid-19 self-declaration", wear FFP2 masks at all times, take PCR and antigen tests upon the participants' first entry to the Council of Europe, as well as perform regular (daily) self-tests during their participation in the part-session.

As during previous part-sessions, the possibility of organising unofficial or social events, as well as exhibitions and receptions, is suspended. The public gallery will continue to remain closed.

# B. Observation of elections

Morocco: parliamentary elections (8 September 2021): the Bureau approved the <u>report</u> of the ad hoc committee.

**Russian Federation: parliamentary elections (19 September 2021)**: the Bureau took note of the <u>memorandum</u> by the Chairperson of the Election Assessment Mission and decided to declassify it.

**Bulgaria: presidential and early parliamentary elections (14 November 2021)**: the Bureau took note of the <u>statement</u> by the observation mission.

# C. Other decisions by the Bureau

**References and transmissions to committees:** the Bureau approved the references and transmissions as set out in Appendix 2, subject to ratification by the Assembly.

**Cooperation with the European Parliament and other EU institutions**: the Bureau took note of the state of play of cooperation with the European Parliament and other EU institutions, noting that, in 2021, cooperation mainly focused on three main lines: Committee hearings with members of the European Parliament on issues of mutual interest; bilateral meetings between Assembly rapporteurs and European Union representatives; and high-level contacts between the President of the Assembly and the President of the European Parliament and European Commissioners.

**Expenditure of the Parliamentary Assembly for the 2022 financial year**: the Bureau took note of the memorandum prepared by the Secretary General of the Assembly and the information contained therein regarding the total appropriation for 2022 for the Parliamentary Assembly.

**Apportionment of the allocation to political groups for 2022**: the Bureau took note of the memorandum prepared by the Secretary General of the Parliamentary Assembly and approved the proposals contained in the document.

**Meetings of the Standing Committee and the Bureau in 2022**: the Bureau approved the proposals set out in Appendix 3.

# II. <u>Standing Committee – 25-26 November 2021</u>

- heard welcome addresses by Mr Roberto Fico, President of the Italian Chamber of Deputies, and Ms Maria Elisabetta Alberti Casellati, President of the Italian Senate;

- held an exchange of views with Mr Luigi Di Maio, Italian Minister of Foreign Affairs and International Cooperation, Chairperson of the Committee of Ministers of the Council of Europe;

- heard a statement by Ms Marta Cartabia, Italian Minister of Justice, in the framework of the discussion on the report on *Fighting corruption, general principles of political responsibility*;

- ratified the credentials of new members of the Assembly submitted by the delegations of Croatia, Denmark, Luxembourg, Malta, Norway and Ukraine;

- approved changes in the composition of Assembly committees;

- took note of the preliminary draft agenda of the first part-session of the Assembly (24-28 January 2022);

- took note of the report of the Ad hoc Committee of the Bureau on the observation of the parliamentary elections in Morocco (8 September 2021);

- held an exchange of views in the framework of the International Day for the Elimination of Violence against Women on *the role of men in stopping gender-based violence*, and heard contributions by Mr Michele Nicoletti, Professor at the University of Trento, Member of the Italian network on the Istanbul Convention, and Ms Simona Lanzoni, Vice-President of the Group of Experts on Action against Violence against Women and Domestic Violence of the Council of Europe (GREVIO);

- held a current affairs debate on The situation of migrants on the border between Poland and Belarus;

- heard a statement by Ms Grainne O'Hara, UNHCR's Director for International Protection, in the framework of the debate on 70th anniversary of the 1951 Refugee Convention: the Council of Europe and the international protection of refugees;

On 17 January 2022, the Assembly launched the call for nominations for the 2022 edition of the <u>Václav Havel</u> <u>Human Rights Prize</u> (Appendix 4). The deadline for submitting nominations is **30 April 2022**.

**Mr Titus Corlăţean** (Romania, SOC) and **Mr Claude Kern** (France, ALDE), rapporteurs of the *Committee on the Honouring of Obligations and Commitments by Member States of the Council of Europe (Monitoring Committee),* carried out a fact-finding visit to Tbilisi on 8-10 December 2021.

# > The situation of migrants on the border with Belarus

On 18 and 19 November 2021, **Mr Pierre-Alain Fridez** (Switzerland, SOC), Chairperson of the *Committee on Migration, Refugees and Displaced Persons*, and **Ms Anne-Mari Virolainen** (Finland, EPP/CD), rapporteur on *Increased migration pressure on the borders of Latvia, Lithuania and Poland with Belarus*, carried out a fact-

finding visit to Poland. Although this fact-finding visit took place outside the period covered by the present Communication, it is important to highlight it, as it brough a substantial input into the Assembly's current affairs debate held during the Standing Committee meeting, in Rome.

# VIII. Cooperation with the Venice Commission

> A representative of the Venice Commission gave legal advice to the PACE delegation which observed the parliamentary elections in the Kyrgyz Republic, on 28 November 2021.

> On 10 December 2021, during the 129<sup>th</sup> plenary session of the Venice Commission, the Presidential Committee of the PACE held an exchange of views with the Enlarged Bureau of the Venice Commission, focusing on ongoing co-operation between the two institutions.

➢ Ms Alexandra Louis (France, ALDE) attended the 129<sup>th</sup> Plenary session of the Venice Commission in Venice (10-11 December 2021), in her capacity as institutional representative of the Assembly on behalf of the Committee on Legal Affairs and Human Rights.

> On 13 December 2021, in the framework of the preparation of a report on *Combating rising hate against LGBTI people in Europe* (Rapporteur: Mr Fourat Ben Chikha, Belgium, SOC), the Committee on Equality and Non-Discrimination received the opinion of the Venice Commission on the compatibility with international human rights standards of Act LXXIX of 2021 enacted by the Hungarian Parliament on 15 June 2021, prepared at the Committee's request.

> On 14 December 2021, in the framework of the preparation of a report on *The honouring of obligations* and commitments by the Russian Federation (rapporteurs: Mr Axel Schäfer, Germany, SOC, and Ms Ria Oomen-Ruijten, Netherlands, EPP/CD), the Committee on the Honouring of Obligations and Commitments by Member States of the Council of Europe (Monitoring Committee) decided to request the opinion of the Venice Commission on amendments to the Federal Law "On the Bar and the Legal Profession in the Russian Federation".

# Václav Havel Human Rights Prize 2022: call for nominations

### 16/01/2022 Prizes



The Parliamentary Assembly of the Council of Europe (PACE), in partnership with the <u>Václav Havel Library</u> and the <u>Charta 77 Foundation</u>, has today issued a call for nominations for the 2022 Václav Havel Human Rights Prize.

The Prize, created in 2013, alms to reward outstanding civil society action in defending human rights in Europe and beyond. Candidates should have made a real difference to the human rights situation of a given group, been instrumental in uncovering large-scale systemic violations, or have successfully mobilised public opinion or the international community for a cause.

The deadline for submitting nominations for the tenth edition of the Prize is 30 April 2022.

Nominations should be sent to the Parliamentary Assembly by e-mail to the following address: http://web.oace.int.using the form available on the Pdze web.oace. They should be signed by at least five sponsors and submitted in either English or French.

The Prize, which will be awarded in October 2022 in Strasbourg, consists of a sum of €60,000, a trophy and a dipioma.

Since 2013, it has been awarded successively to Ales Bialiatski (Belarus), Anar Mammadi (Azerbaljan), Ludmilia Alexeeva (Russian Federation), Nadia Murad (Iraq), Murat Arsian (Turkey), Oyub Titlev (Russian Federation), Jointly to liham Tohti (China) and the Youth Initiative for Human Rights (Balkans), Loujain Alhathioui (Saudi Arabia), and last year to Maria Kalesnikava (Belarus).
