Communication by the Secretary General of the Parliamentary Assembly at the 1433rd meeting of the Ministers' Deputies^{*} (4 May 2022)

^{*} This document covers past activities of the Assembly since the meeting of the Bureau on 21 April 2022 and future activities up to the meeting of the Bureau on 30 May 2022 (Dublin).

I. Assembly's response to the Russian Federation's aggression against Ukraine

As a follow-up to the Parliamentary Assembly's Extraordinary plenary session, the Assembly's Opinion 300(2022) and the subsequent decision of the Committee of Ministers to expel the Russian Federation from the Council of Europe, the Bureau of the Assembly decided to place on the agenda of the 2022 April part-session a general policy debate entitled "Consequences of the Russian Federation's continued aggression against Ukraine: role and response of the Council of Europe". The aim of the general policy debate was to explore ways of providing concrete and targeted support for Ukraine in the context of the Russian Federation's aggression, as well as to identify the ways for the Council of Europe and the Assembly to respond to the consequences of this aggression, as well as to the Russian Federation's expulsion. As a result, Recommendation 2228(2022) and Resolution 2433(2022) were adopted; both texts, containing specific recommendations addressed notably to member States and the Committee of Ministers, could feed into the debates of the 132nd Session of the Committee of Ministers to be held in Turin, on 20 May 2022.

At the same time, the Assembly held two debates which are specifically related to the consequences of the Russian Federation's aggression against Ukraine, including the role that the Council of Europe could play in this respect, as follows:

- The Russian Federation's aggression against Ukraine: ensuring accountability for serious violations of international humanitarian law and other international crimes (debate under urgent procedure, Recommendation 2231 (2022) and Resolution 2436 (2022));
- How to put confiscated criminal assets to good use? (Recommendation 2229 (2022) and Resolution 2434 (2022)).

Building upon the relevant Resolutions and Recommendations adopted, a Joint informal meeting between the Bureau of the Ministers' Deputies, the Presidential Committee of the Assembly and the Secretary General was held on 28 April 2022, to discuss the Council of Europe's coordinated action for Ukraine. The preparation of the Turin Ministerial Session as well as the idea of a possible Fourth Summit of the Council of Europe were among the issues discussed at the meeting.

On 28 April 2022, the Bureau of the Assembly drew up the preliminary draft agenda of the June 2022 partsession, putting on the agenda a series of reports relating to the various aspects of the consequences of the Russian Federation's aggression against Ukraine, notably:

- Recent challenges to security in Europe: what role for the Council of Europe?;
- Humanitarian consequences and internal and external migration in connection with the aggression of the Russian Federation against Ukraine;
- Alternative care for unaccompanied and separated migrant children;
- Justice and security for women in peace reconciliation.

The preliminary draft agenda of the June 2022 part-session is in Appendix 5.

Finally, it is worth mentioning that, while deciding that, from 1 May 2022 on, Assembly meetings will be held in the physical presence of members, the Bureau of the Assembly agreed to allow the members of the Ukrainian delegation to participate in meetings online, should they be prevented from traveling to the venue of the meeting. This measure will be applied for as long as the situation may require so.

II. Decisions taken by the Bureau (21 April and 28 April 2022)

• **Requests for debate under urgent procedure**: on 21 April, the Bureau took note of the request to hold a debate on *"Russian Federation's aggression against Ukraine: ensuring accountability for serious violations of international humanitarian law"* tabled by the Committee on Legal Affairs and Human Rights, decided to recommend to the Assembly to hold this debate, and to refer the matter to the Committee on Legal Affairs and Human Rights.

- Election of a judge to the European Court of Human Rights: on 21 April, the Bureau took note of the report drawn up by the Committee on the election of judges for the post of a judge in respect of Ukraine, subject to ratification by the Assembly in the Progress report (<u>Doc. 15503 Addendum 2</u>).
- Relations with Belarus: implementation of paragraph 18.2. of Opinion 300(2022) on "Consequences of the Russian Federation's aggression against Ukraine": in view of the participation of Belarus in the Russian Federation's aggression against Ukraine, on 21 April, the Bureau decided to suspend relations between the Assembly and the Belarusian authorities in all its activities.

• References and transmissions to committees:

- The Bureau considered and approved the references and transmissions as set out in Appendix 3.
- Technical corrections to the Assembly's Rules of Procedure following the exclusion of the Russian Federation from the Council of Europe: on 21 April, the Bureau requested the Secretariat of the Committee on Rules of Procedure, Immunities and Institutional Affairs to introduce technical corrections to the Rules of Procedure as a consequence of the termination of Russian Federation's membership in the Council of Europe.
- **Format of Assembly meetings from 1 May 2022**: on 21 April, the Bureau decided to hold Assembly plenary sessions and Committee meetings in physical presence of members as from 1 May 2022 on.
- Second part-session of 2022 (Strasbourg, 25-28 April): on 28 April, the Bureau approved the followup proposals made by the Secretary General of the Assembly to texts adopted by the Assembly, as set out in Appendix 2.
- Standing Committee (Dublin, Tuesday, 31 May 2022): on 28 April, the Bureau took note of the draft agenda (Appendix 4).
- Third part-session of 2022 (Strasbourg, 20-24 June): on 28 April, the Bureau drew up the preliminary draft agenda (Appendix 5).
- European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT) - Lists of candidates in respect of Monaco and Georgia: on 28 April, the Bureau approved the lists of candidates in respect of Monaco and Georgia to be forwarded to the Committee of Ministers.
- Institutional representation of the Parliamentary Assembly in 2022: the Bureau updated the appointments as set out in Appendix 6.
- Issues raised by committees:
 - The Bureau authorised the rapporteur on "Pegasus and similar spyware and secret state surveillance" (Committee on Legal Affairs and Human Rights), to carry out a fact-finding visit to Israel in the framework of the preparation of his report.
- Meetings elsewhere than Strasbourg or Paris:
 - The Bureau authorised the Committee on Migration, Refugees and Displaced Persons to meet in Athens, on 19-20 September 2022;
 - The Bureau authorised the Sub-Committee on Europe Prize (Committee on Social Affairs, Health and Sustainable Development) to meet in Amilly (France), on 1-2 July 2022, and in Izmir (Turkey), on 22-23 September 2022.

III. Second part of the Ordinary Session of 2022 (25 - 28 April 2022)

B. Elections

On 26 April 2022, the Parliamentary Assembly elected Mr Mykola Gnatovskyy as judge to the European Court of Human Rights in respect of Ukraine. The voting result is available <u>here</u>.

C. Media Coverage

The 2022 April session of the Parliamentary Assembly generated considerable media coverage, with 47 journalists present in Strasbourg to report on it, and around 300 articles (provisional figures) appearing in the international press. The Italian (132), Ukrainian (37) and international news coverage (19) accounts for the bulk of the total media coverage.

The address by the President of the Italian Republic, Mr Sergio Matarella, received an unprecedented international and regional coverage (RAI TV, SKY TG24, Tgcom 24, II Corriere della Sera, La Repubblica, La Stampa, II Giornale, II Messagero, Avvenire, ANSA, Ukrinform, TASS...). The Communication from the CM by the Italian Minister of Foreign Affairs and International Co-operation, Mr Luigi Di Maio was also largely reflected in the press.

The urgent debate on the "Russian Federation's aggression against Ukraine: ensuring accountability for serious violations of international humanitarian law" generated both substantive and quality coverage at an international level in terms of articles and TV reports (CNN, ARD, Frankfurter Allgemeine Zeitung, Der Spiegel, Washington Post, EUObserver, RFI, Mediapart, Agence Europe, Ukrainskaya Pravda and national news agencies...). The general policy debate on the "consequences of the Russian Federation's continued aggression against Ukraine: the role and response of the Council of Europe" also received substantial international coverage. More than 70 TV stations worldwide requested Eurovision live feeds of the two debates on Ukraine.

In the margins of the session, the reaction by PACE President to Osman Kavala's conviction to an aggravated life sentence created an important quality coverage at international level (Euronews, Turkey, Deutsche Welle, Turkey, CNN, TV5Monde, France TV info, Le Figaro, Le Nouvel Obs, Der Spiegel, Frankfurter Allgemeine Zeitung, Die Zeit, De Volkskrant...).

As regards the Assembly's social media output, the session generated around 260,000 impressions on Twitter, a reach of about 4,800 on Facebook, and around 4,000 views on YouTube, many in Kyiv. The top posts concerned the Assembly's headline debate on the consequences of the Russian aggression against Ukraine.

After several part-sessions operating remotely, the MediaBox, a web-TV studio available to all those making news at the Assembly in Strasbourg, once again proved its usefulness with 10 interviews with parliamentarians published on the PACE website and social media supports.
