Synopsis

14 December 2010

The Bureau of the Assembly, meeting on 13 December 2010 in Paris, with Mr Mevlüt Çavuşoğlu, President of the Assembly, in the Chair, as regards:

- **Standing Committee (Antalya (Turkey), 12 November 2010):** follow-up to the current affairs debate on “Recent violent attacks on Christians and other religious communities in Iraq” : referred this matter to the Political Affairs Committee for report;
- **1st Assembly Part-Session of 2011 (24-28 January 2011):**
 - i. Request for debate under urgent procedure:* took note of the request by the Group of the European People’s Party (EPP/CD) to hold a debate under urgent procedure on “the religious cleansing of Christians in Iraq and other regions of the world” and decided to return to this question at its next meeting;
 - ii. Updating of the draft agenda :* updated the draft agenda;
 - iii. Draft agenda of the Joint Committee:* confirmed its decision to put the following items on the agenda of the Joint Committee to be held on 27 January 2011 : the accession of the European Union to the European Convention of Human Rights and Council of Europe reform;
- **Communications:** took note of communications by the Secretary General and the Deputy Secretary General of the Council of Europe as well as the Secretary General of the Parliamentary Assembly;
- **References and transmissions to committees:** see Appendix I;
- **Implementation of paragraph 23 in Assembly Resolution 1740 (2010) on “The situation of Roma in Europe and relevant activities of the Council of Europe”:** approved a draft letter addressed to the Chairperson of the European Roma and Travellers Forum containing proposals for cooperation with the Forum;
- **Relations with the Interparliamentary Assembly of the CIS:** took note of a Secretariat memorandum and asked the Secretariat to consider, in conjunction with the Secretariat of the Interparliamentary Assembly of the CIS, modalities for future cooperation between the two institutions;
- **Request for Partner for Democracy status with the Parliamentary Assembly submitted by the Palestinian National Council:** took note of a memorandum prepared by the Secretariat and decided to refer this request to the Political Affairs Committee for report as well as to the Committee on Legal Affairs and Human Rights and to the Committee on Equal Opportunities for Women and Men for opinion;
- **Observation of elections : Moldova : early parliamentary elections (28 November 2010):** took note of oral accounts and of a press release concerning the election observation mission by the ad hoc committee as the final report had not yet been published;
- **Cooperation with the European Parliament:** took note of information provided by the President of the Assembly;
- **Budgetary questions:**
 - took note of the information provided by the Secretariat and decided to maintain, in 2011, the austerity measures already implemented in 2010;

- approved the apportionment of the allocation to the political groups for 2011;

- **Issues raised by committees:**

i. Committee on Economic Affairs and Development: decided, further to a proposal from the committee, that the Assembly would, from now on, hold a debate on the activities of the European Bank for Reconstruction and Development (EBRD) every other year;

ii. Political Affairs Committee: heard an account by Mr von Sydow, Chairperson of the Committee, on his visit to Kosovo¹ on the eve of the elections held there on 12 December 2010;

- **Assembly representatives for official activities:** appointed Mr Herkel (EPP/CD, Estonia) to represent the Assembly at the international conference on "Prevention of Terrorism: Prevention tools, Legal Instruments and their implementation; to take place in Istanbul (Turkey) on 16 and 17 December 2010;
