Synopsis

11 April 2011

The Bureau of the Assembly, meeting on 11 April 2011 à Strasbourg, with Mr Mevlüt Çavuşoğlu, President of the Assembly, in the Chair, as regards:

- Standing Committee (Paris, 11 March 2011): approved the proposals for follow-up to the texts adopted by the Assembly at the Standing Committee;
- 2011 Second part-Session (Strasbourg, 11-15 April 2011):
 - i. Requests for debates under urgent procedure
 - a. "Large scale arrival of irregular migrants, asylum seekers and refugees on Europe's Southern shores", following a request submitted by the Committee on Migration, Refugees and Population: decided to recommend to the Assembly to hold a debate under urgent procedure on the subject and to refer the matter to the Committee on Migration, Refugees and Population for report;
 - b. "The situation in Northern Africa", following a request by five leaders of political groups on behalf of their groups: decided to recommend to the Assembly to hold a current affairs debate on this issue and appointed Mr Gross to open this debate.
 - ii. Election of a judge to the European Court of Human Rights in respect of France, Norway and Switzerland:
 - a. took note of the recommendations of the Sub-committee on the election of judges to the European Court of Human Rights in respect of Norway and Switzerland and decided to transmit them to the members of the Assembly;
 - b. as regards the election of a judge to the European Convention on Human Rights in respect of France, took note of the fact that the procedure has been interrupted, as one of the three candidates has withdrawn his candidature. The French government has therefore been asked as stipulated in paragraph 2 in the appendix to Resolution 1432 (2005) to provide the Assembly with the name of another person in order to complete the list.
 - iii. Draft agenda: updated the draft agenda:
- Progress Report of the Bureau of the Assembly and of the Standing Committee (29 January 11 April 2011): Rapporteur: Mrs Hurskainen (Finland, SOC) : approved the Progress Report;
- References and transmissions to committees: approved the references and modifications to references as presented in appendix 1, subject to ratification by the Assembly;
- **Communications:** took note of communications by the President, the Secretary General and the Deputy Secretary General of the Council of Europe as well as the Secretary General of the Parliamentary Assembly;
- **Cooperation with European Parliament:** took note of the report on the meeting of the Joint Informal Body (14 March 2011, Brussels);

Election observation:

- i. Kazakhstan: early Presidential elections (3 April 2011): took note of the oral report of the Chairperson of the ad hoc committee which observed the early presidential elections in Kazakhstan;
- *ii.* "The former Yugoslav Republic of Macedonia": possible early parliamentary elections (5 June 2011 [date tbc]): decided in principle and subject to confirmation of this election and to the receipt of an invitation by the competent authorities of "the former Yugoslav Republic of Macedonia" to observe the early parliamentary elections (5 June 2011 date tbc.), to constitute an ad hoc committee to observe these elections, composed of 20 members in accordance with the D'Hondt system (EEP/CD: 7, SOC: 6; EDG: 3, ALDE: 3, UEL: 1) and to authorise a pre-electoral mission approximately one month ahead of the elections;
- Ad hoc committee of the Bureau on recent detentions, prosecutions and convictions of members of the opposition in Belarus: approved the list of members of the ad hoc committee and decided to appoint Mr Tomáš Jirsa (Czech Republic, EDG) as Chairperson of the ad hoc Committee;
