Revised Synopsis

8 June 2011

The Bureau of the Assembly, meeting on Thursday, 26 May 2011 in Kyiv, with Mr Mevlüt Çavuşoğlu, President of the Assembly, in the Chair, as regards:

- **2011 Second ordinary part-Session (Strasbourg, 11-15 April)**: approved the proposals for follow-up to texts adopted by the Assembly;
- **Standing Committee meeting (Kyiv, 27 May 2011)**: took note of the draft agenda;
- **2011 Third ordinary part-Session (Strasbourg, 20-24 June)**: drew up the draft agenda for the Third part-Session;
- **Communications**: took note of the Communications by the Secretary General and the Deputy Secretary General of the Council of Europe, as well as by the Secretary General of the Assembly;
- **References and transmissions to committees**: see Appendix I;
- **European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT)** :
 - . took note of the written information about the constitution of the list, provided by the Chairperson of the Spanish delegation ;
 - . decided to transmit this list to the Committee of Ministers ;
- **Observation of elections**:
 - i. **Kazakhstan: early Presidential elections (3 April 2011)**: approved the report of the ad hoc committee presented by its Chairperson;
 - ii. **"The former Yugoslav Republic of Macedonia": early parliamentary elections (5 June 2011)**: took note of the press release on the pre-electoral mission to this country (17-18 May);
 - iii. **Turkey: observation of parliamentary elections (12 June 2011)** : took note of the press release on the pre-electoral mission to this country (17-18 May);
 - iv. **Tunisia: election of a Constituent National Assembly (24 July 2011)** : decided to observe the election of a Constituent National Assembly in Tunisia; constituted an ad hoc committee to observe these elections, composed of 20 members in accordance with the D'Hondt system (EPP/CD: 7, SOC: 6; EDG: 3, ALDE: 3, UEL: 1) and authorised a pre-electoral mission approximately one month ahead of the elections, composed of five members, one from each group, who are also members of the ad hoc committee;
- **Issues raised by committees** :
 - i.. **Follow-up to Resolution 1583 (2007) "Improving the participation of members in Assembly plenary sessions and committee meetings"**: took note of the oral and written report of the Chairperson of the Committee on Rules of Procedure, Immunities and Institutional Affairs and invited the President of the Assembly to write to the chairpersons of the delegations with low participation rates and the speakers of the parliaments concerned, to inform them of the situation and possibly to hold a meeting with the chairpersons of the delegations concerned;

- **Other business:**
- **Composition of the Committee on Rules of Procedure, Immunities and Institutional Affairs:** on the basis of a proposal from the EPP/CD political group, nominated a member of this committee, subject to ratification by the Assembly;
- **Assembly representatives for official activities :** see Appendix II;
- **Analysis of the use made by the Assembly's political groups of their allocations for 2010:** approved the report submitted by the Committee on Economic Affairs and Development;
- **Bureau and Standing Committee meetings in Edinburgh:** accepted the invitation from the Chairperson of the delegation of the United Kingdom to hold the meetings of the Bureau and Standing Committee in Edinburgh, respectively on 24 and 25 November 2011;
- **Date and place of the next meeting:** decided to hold its forthcoming meetings as follows:
 - . Monday 20 June 2011, Strasbourg, at 8 am;
 - . Friday 24 June 2011, Strasbourg, at 8.30 am.
