SYNOPSIS N° 2004/078 23 JUNE 2004

The Sub-Committee on the Cultural Heritage meeting on 22 June 2004 with Mr Legendre in the chair:

- discussed Assembly involvement in intergovernmental activities in the cultural heritage field on the basis of presentations by the secretariat of DG IV and with regard to:
 - European Framework Convention on the Cultural Heritage decided to organise in Paris on 2 December a hearing on the convention and its place in the context of existing international instruments,
 - European Heritage Days proposed that Mr de Puig represent the Assembly at the European opening events in Barcelona on 3-4 September 2004 and asked that members be associated with corresponding national events on a systematic basis,
 - Regional Programme for Cultural Heritage in South East Europe welcomed positive developments in Kosovo and in particular the setting up of an International Independent Commission of UNMIK, Council of Europe and EU,
 - European Cultural Routes expressed interest in the promotion of existing and new routes especially involving the new democracies;
- was informed by Mr O'Hara (General Rapporteur on the Cultural Heritage) on the cultural and environmental impact of the construction of the Olympic boating centre at Marathon, welcomed the fact that the site appeared to be well managed and decided to keep in view the effects of the Olympic Games on archaeological sites there and elsewhere in Greece;
- looked forward to continuing cooperation with Europa Nostra;
- decided to hold its next meeting in Strasbourg during the next part-session (4-8 October 2004).
