To the Members of the Committee on Culture, Science and Education

Synopsis

of the meeting held in Strasbourg on 28 and 30 April 2009

The **Committee on Culture, Science and Education,** with Mrs Brasseur and then Mr Dzembritzki in the chair:

- **regretted** the decision of the Assembly to take off its agenda for the present part-session the debate on the *funding of public service broadcasting* (Rapporteur: Mr Laukkanen, Finland, ALDE) and decided to propose it for debate at the June part-session, possibly jointly with the report on the *promotion of Internet and online media services appropriate for minors;*

- **approved** a report and **adopted** unanimously a draft recommendation on *History teaching in conflict and post-conflict areas* (Rapporteur: Miss Keaveney, Ireland, ALDE) to be presented to the June part-session;

- held an **exchange of views** with Mrs Maud de Boer-Buquicchio, Deputy Secretary General of the Council of Europe, on the *promotion of Internet and online media services appropriate for minors* (Rapporteur: Mr Kozma, Hungary, SOC), **approved** a report and **adopted** unanimously a draft recommendation to be presented to the June part-session;

- **discussed** an outline for a report on *copyright in Europe* (Rapporteur: Mr Arnaut, Portugal, EPP/CD) with the participation of Mr Christophe Geiger, Director General and Senior lecturer, Centre for International Intellectual Property Studies (CEIPI), Strasbourg;

- **welcomed** an invitation from the Head of the Turkish parliamentary delegation, to meet in Istanbul, European capital of culture 2010;

- was **informed** by Miss Keaveney of the meeting of the Sub-Committee on Youth and Sport in Mollina, Spain (24-25 March 2009);

- **took note** that the Sub-Committee on the Media had been authorised to meet on the occasion of the Council of Europe Conference of Ministers responsible for Media and New Communication Services (Reykjavik, 28-29 May 2009);

- **appointed** the following Rapporteurs:

- Mr Anghel (Romania, EPP/CD) for the opinion on *minority protection in Europe: best practices and deficiencies in implementation of common standards*
- Mr Kaźmierczak (Poland, EPP/CD) for a contribution on the activities of the OECD

- **took note** of the reply by the Committee of Ministers to Recommendation 1836 (2008) on e-learning (Rapporteur Mr Fischer, Germany, EPP/CD) and of the Rapporteur's comments on it;

- **designated** representatives to forthcoming meetings;
 - Mr O'Hara European Museum of the Year Award Seminar and ceremony (Bursa, Turkey, 6-9 May)
 - Mr McIntosh conference on media and terrorism (Reykjavik, 27 May)
 - Mrs Duesund opening ceremony of the Wergeland Centre (Oslo, 28-29 May)

- **appointed** Mrs Postanjyan to replace Mr Hovannisian (Armenia), who has left the Assembly, on its Sub-Committees on the Cultural Heritage and the Media;

- asked members to suggest candidates for the North South Prize 2009 by its next meeting at the latest;
- decided to hold its next meeting in Paris (Council of Europe office) on 20 May 2009.
