Synopsis of the meeting held in Strasbourg on 23, 24 and 25 June 2015

The Committee on Culture, Science, Education and Media, meeting in Strasbourg with Ms Adele Gambaro (Italy, ALDE) in the Chair,

- on Tuesday 23 June 2015 from 2 p.m. to 3.30 p.m., as regards:
- Freedom of religion and living together in a democratic society (Rapporteur: Mr Rafael Huseynov, Azerbaijan, ALDE): unanimously adopted a draft resolution and a draft recommendation, and unanimously approved a report;
- Situation in Hungary following the adoption of Assembly Resolution 1941 (2013) (Rapporteur for opinion: Mr Gvozden Srećko Flego, Croatia, SOC): adopted an opinion with four amendments;
- Towards a European framework of competences for democratic citizenship, human rights and intercultural dialogue (Rapporteur: Mr Jacques Legendre, France, EPP/CD): considered a draft report, held an exchange of views with Ms Snežana Samardžić-Marković, Director General of Democracy of the Council of Europe, and decided to change the title of the report to "Towards a framework of competences for democratic citizenship";
- **Promoting city diplomacy in the field of culture** (Rapporteur: Alexander, The Earl of Dundee, United Kingdom, EC): considered a draft report and decided to change the title of the report to "Promoting city-to-city cooperation in the field of culture";
- World Forum for Democracy (18-20 November 2015): was informed by Ms Snežana Samardžić-Marković, Director General of Democracy of the Council of Europe, on the state of preparation of Forum; proposed Mr Paolo Corsini (Italy, SOC), Ms Adele Gambaro (Italy, ALDE), Mr Francesco Maria Giro (Italy, EPP/CD), Mr Rafael Huseynov (Azerbaijan, ALDE) and Ms Ioanneta Kavvadia (Greece, UEL) as members to the ad hoc committee of the Bureau attending the World Forum for Democracy;
- on Wednesday 24 June 2015 from 2 p.m. to 3.30 p.m., as regards:
- **Increasing transparency of media ownership** (Rapporteur: Ms Gülsün Bilgehan, Turkey, SOC): took position on amendments to the draft resolution and took note that no amendments had been tabled to the draft recommendation;
- **Media responsibility and ethics in a changing media environment** (Rapporteur: Mr Volodymyr Ariev, Ukraine, EPP/CD): took note that no amendments had been tabled to the draft resolution and to the draft recommendation:

- **Platform for the protection of journalism and the safety of journalists**: decided to postpone this item to its next meeting;
- Access to school and education for all children (Rapporteur: Mr Gvozden Srećko Flego, Croatia, SOC): considered a preliminary draft report, held an exchange of views with Mr Sjur Bergan, Head of the Education Department and Director of Democratic Citizenship and Participation ad interim, Council of Europe Directorate General of Democracy (DG II), and heard two representatives of the Kyrgyz Parliament, Ms Elmira Imanalieva and Mr Saidulla Nyshanon, who expressed interest in the possibility to cooperate in the field of education:
