## Synopsis of the meeting held in Strasbourg on 30 September, 1 and 3 October 2019

**The Committee on Culture, Science, Education and Media**, meeting in Strasbourg on 30 September, 1 and 3 October 2019 with Lord George Foulkes (United Kingdom, SOC) and Mr Bernard Fournier (France, EPP/CD) in the Chair,

## Monday, 30 September 2019 from 2 pm to 2.40 pm, as regards:

- **Media education in the new media environment** (*Rapporteur: Ms Nino Goguadze, Georgia, EC/DA*): took note of the explanatory memorandum, then unanimously adopted a draft resolution, thereby adopting the report;
- **Strengthening the role of young people in the prevention and resolution of conflicts** (*Rapporteur: Ms Inka Hopsu, Finland, SOC*): heard a declaration of absence of conflict of interest from the rapporteur and held a hearing with the participation of Mr Nikola Puharić, Croatia, Mr Ivan Djuric, Serbia, Mr Bojan Stanković, Serbia, Ms Marigona Shabiu, Kosovo<sup>1</sup>, and Ms Edina Hasanaga Cobaj, Montenegro, representatives of the NGO Youth initiative for human rights (YIHR), winner (*ex-aequo* with Ilham Tohti) of the 2019 Vaclav Havel Human Rights Prize;

# Transmission of traditional crafts and heritage related skills

Motion for a resolution

Tabled by the Committee on Culture, Science, Education and Media, in compliance with the Rule 25.2

This motion has not been discussed in the Assembly and commits only those who have signed it

Industrialisation, urban development, mass tourism, the standardisation of lifestyles and of the various forms of knowledge and skills, all constitute a context which places heritage related skills and traditional crafts in a vulnerable position.

In the follow-up to the PACE Resolution 2269 and Recommendation 2148 (2019) on "Safeguarding and enhancing intangible cultural heritage in Europe", the Assembly could consider specific measures and incentives that are needed to sustain traditional crafts but also to help them to be open to innovation and the use of new technologies. The aim should be to enable traditional crafts to develop and evolve with the times, and not to rigidly entrench age-old practices seeking to shield this area of intangible cultural heritage.

Crafts offer a huge repository of skills. The "maker movement" has opened up new spaces that use technologies and creativity to repair, revise and refashion products, as well as to make new products. Adequate training or education are required to ensure the preservation and transmission of those skills, but also to widen their range, so that they can be a resource for the future, and for innovation.

The Assembly could recommend expanding the ongoing activities under the European Heritage Strategy for the 21st century and the Council of Europe Framework Convention on the Value of Cultural Heritage for Society (Faro Convention) to assist member States in this field.

# The role of culture and education in a new technological era

Motion for a resolution Tabled by the Committee on Culture, Science, Education and Media, in compliance with the Rule 25.2

This motion has not been discussed in the Assembly and commits only those who have signed it

New technologies and their applications are blurring the boundaries between human and machine, between online and offline activities, between the physical and the virtual world, and between the natural and the artificial. They raise some fundamental questions: what is human? What are the boundaries to be respected to preserve what we can define as human? What kind of society do we want for the future and how to prepare the cohabitation of humankind with intelligent machines? Citizens ought to take an active part in replying to these fundamental issues and not be subject to corporate interests.

In the follow up to the PACE Recommendation 2102 (2017) on "*Technological convergence, artificial intelligence and human rights*", the Assembly should explore ways to reinforce individual capacity to engage in a wider reflection not only with the view to regulate the advancements of science and technology and their implementation, but more fundamentally to question - early on in the process - their essence, their direction and whether they are acceptable and beneficial to society as a whole.

Cultural and educational sectors - including individual artists, cultural activists, associations, cultural institutions and schools - have a key role to play in this context, by stimulating critical thinking and ethical analysis in this new technological era which would be so fundamental for citizens, and particularly young people, to address numerous challenges in the form of a continuous, open and informed debate.

Specific guidelines to assist and stimulate culture and educational sectors in this important task, should be developed, building on the Council of Europe *acquis* in these domains, and in particular the Framework of Competences for Democratic Culture.
