Synopsis No. 2011/08 6 October 2011

The **Committee on Economic Affairs and Development**, meeting in Strasbourg on 6 October 2011, with Mrs Naghdalyan (Armenia, ALDE), Chairperson, in the chair, as regards:

- The challenges faced by small national economies (Rapporteur: Mrs Marie-Louise Coleiro Preca, Malta, SOC): unanimously adopted a preliminary draft resolution and approved a draft report with a view to presenting the report for debate in the Assembly during the meeting of the Standing Committee on 25 November 2011:
- **Promoting an appropriate policy on tax-havens** (Rapporteur: Mr Dirk van der Maelen, Belgium, SOC): heard a statement by the rapporteur and held an exchange of views on the basis of an introductory memorandum:
- **Measuring the well-being of European citizens** (Rapporteur: Alexander Earl of Dundee, United Kingdom, EDG): heard a statement by the rapporteur and held an exchange of views on the basis of an outline for a report;
- Reply from the Committee of Ministers (Doc. 12725) to PACE Recommendation 1961 (2011) on the "Over-indebtedness of states: a danger for democracy and human rights": heard a statement by its Chair and agreed to return to the issue at its next meeting;
- **Work programme of the Committee:** took note of its revised work programme and was informed about the new initiatives by its members;

  - Meetings of the Bureau of the Assembly on 5 September and 3 October 2011: heard a statement by its Chairperson;
  - Parliamentary Panel and the meeting of the Steering Committee of the Parliamentary Conference on the WTO in the framework of the WTO Public Forum 2010, Geneva, 19-21 September 2011: heard statements by Mr Sasi and Mr Van der Maelen;
  - appointed its representatives to the following events:
    - Meeting of the Executive Council of the North-South Centre on 2 November 2011 and 2011 Lisbon Forum of the North-South Centre on 3-4 November 2011 in Lisbon: Mr Sasi, the Assembly's representative for the Committee on Economic Affairs and Development to the Executive Council of the Centre,;
    - OECD High-Level Parliamentary Seminar "Addressing the social impact of the crisis", Paris (OECD Conference Centre), 10 October 2011: Mr Elzinga, Chairman of the Sub-Committee on International Economic Relations (at no cost to the PACE budget);
- authorised Mr Elzinga, Rapporteur on the European Bank for Reconstruction and Development (EBRD), to carry out a fact-finding visit to the EBRD for the purposes of his report;
