The Committee on Equal Opportunities for Women and Men, meeting in Strasbourg on 10 April 2006
with Ms Cliveti (Romania, SOC) in the Chair:

as regards:

- *Stop trafficking in women before the FIFA World Cup:*
 - appointed Ms Vermot-Mangold (Switzerland, SOC) as Rapporteur;

- *Parliaments united combating domestic violence against women* (Rapporteur : Ms Cliveti, Romania, SOC): heard a statement by Ms Hägg (Sweden, SOC), Chairperson of the Sub-committee on violence against women, on the hearing which was held in Stockholm on Thursday 30 March 2006, and invited the Rapporteur to prepare a draft report for adoption at the Committee's next meeting in Paris on 15 May 2006 with a view to submitting it to the Assembly for debate during the June 2006 part-session in the presence of Mrs Ertürk, United Nations Special Rapporteur on Violence against Women;

- *Image of women in advertising* (Rapporteur : Ms Laloy, Belgium, SOC): held an exchange of views on the preparation of the hearing to be held in Paris on Tuesday 16 May 2006;
