**The Committee on Equal Opportunities for Women and Men**, meeting in Paris on 12 September 2006 with Ms Cliveti (Romania, SOC) in the Chair:

as regards:

- *The need to reconcile work and family life* (Rapporteur: Mrs Pericleous-Papadopoulos, Cyprus, ALDE): considered a draft report, amended and unanimously adopted a preliminary draft recommendation with a view to presenting the report for debate at the October 2006 part-session of the Assembly;
- *Abduction and "re-education" of Muslim women and children who have become too "Western-minded"* (Rapporteur: Ms Bousakla, Belgium, SOC): debated the title of the report, invited the Rapporteur to organise a hearing on the issue, authorised the Rapporteur to go on a fact-finding visit to Turkey, and asked the Chairperson to seek the Bureau's authorisation for the Rapporteur to go on a fact-finding visit to the Maghreb countries;
- *Sub-Committee on violence against women* :
  - was informed of the outcome of the meeting held in Strasbourg on 29 June 2006;
  - held an exchange of views on the state of preparation of the Council of Europe Campaign to combat violence against women, including domestic violence, in particular its parliamentary dimension;
- *Co-ordination meeting of the contact parliamentarians involved in the parliamentary dimension of the Council of Europe campaign to combat violence against women, including domestic violence (2006-2008)*: prepared the co-ordination meeting to be held in Strasbourg on Thursday, 19 October 2006;
- *Parliamentary seminar on upholding the principle of equality between women and men in civil law, including in family codes*: prepared the seminar to be held in Strasbourg on Friday, 20 October 2006, with the participation of parliamentary representatives of Algeria, Morocco and Tunisia;
- *Appointment of Rapporteurs*: appointed the following Rapporteurs for opinion:
  - Ms Ahlqvist (Sweden, SOC) on women in prison
  - Ms Bilgehan (Turkey, SOC) on the code of good practices of the political parties
  - Ms Stantcheva (Bulgaria, ALDE) on mechanisms to ensure women's participation in decision-making

  - Ms Cliveti (Romania, SOC) to the Congress on “*Women generating peace*” organised by Emakunde (Basque Women’s Institute), San Sebastian (Spain), 23-24 October 2006 (*with no cost to the Assembly*);

- *Statement by representatives at meetings organised by other bodies*: heard a statement by Ms Bilgehan (Turkey, SOC) on the Conference “*Women’s rights in the Euro-Mediterranean region: women as agents of change*”, organised by the North South Centre of the Council of Europe, Lisbon, 30 June – 1 July 2006;

- *Respect for the principle of equality in civil law* (Rapporteur: Ms Smirnova, Russia, EDG): decided to ask the Bureau for an extension of the deadline for the preparation of the report until 26 January 2007;

**resuming** its meeting on 13 September 2006, with Ms Zapfl-Helbling (Switzerland, EPP/CD), First Vice-Chairperson, in the Chair:

- *Sexual assaults linked to “date-rape drugs”* (Rapporteur: Ms Damanaki, Greece, SOC): considered a draft report and unanimously adopted a preliminary draft recommendation with a view to presenting the report at the next Standing Committee ;

- *Prostitution – which stance to take?* (Rapporteur: Mr Platvoet, Netherlands, UEL): held a hearing on this matter with the participation of the following experts:

- Ms Sophie Jekeler, lawyer, Chairperson of the NGO “The Nest” (Belgium), member of the network ENATW-Aretusa
- Ms Terry van der Zijden, De rode Draad, trade union of prostitutes (Netherlands)
- Chris, European Network of Male Prostitutes (United Kingdom)
- Dr Gundo Weiler, STI/HIV team leader in Ukraine, World Health Organisation
- Dr Linda Cusick, University of Paisley (United Kingdom)

- *its next meetings*: decided to meet in:

- **Strasbourg**, during the 2006 4<sup>th</sup> part-session of the Assembly (2-6 October);
- **Strasbourg**, Thursday 19 October 2006: co-ordination meeting of the contact parliamentarians involved in the parliamentary dimension of the Council of Europe campaign to combat violence against women, including domestic violence (2006-2008);
- **Strasbourg**, Friday, 20 October 2006: parliamentary seminar with parliamentary representatives of Algeria, Morocco and Tunisia on *upholding the principle of equality between women and men in civil law, including in family codes*;
- **Madrid**, Friday 24 November 2006: Participation in the launching conference of the Council of Europe campaign to combat violence against women, including domestic violence - *subject to the Bureau’s authorisation* -
- **Paris** (Council of Europe office), Wednesday, 13 December 2006.
