Synopsis of the meeting held in Paris on 11 March 2016

The Committee on Equality and Non-Discrimination, meeting in Paris on 11 March 2016, first with Ms Elena Centemero (Italy, EPP/CD) then with Ms Marit Maij (Netherlands, SOC) in the Chair, as regards:

- Assessing the impact of measures to improve women's political representation (Rapporteur: Ms Elena Centemero, Italy, EPP/CD): considered and approved a draft report and adopted a draft resolution;
- Renewed commitment in the fight against antisemitism in Europe (Rapporteur: Mr Boriss Cilevičs, Latvia, SOC): considered and approved a draft report and unanimously adopted a draft resolution;
- International Day for the Elimination of Racial Discrimination (21 March): considered and approved a draft statement;
- Communication from the Chairperson: heard a communication from the Chairperson;
- Women in the public space: took note of the Chairperson's proposal to work on the theme of Women in the public space and agreed to come back to this item at its next meeting;
- Hearing on "Women and radicalisation leading to terrorism": held an exchange of views with the participation of:
 - Ms Véronique Roy, mother of a young man who converted, became radicalised to take part in the Jihad and died in Syria, Paris (France);
 - Ms Melanie Smith, Researcher and Coordinator, Institute for Strategic Dialogue, London (United Kingdom);
- The protection of the rights of parents and children belonging to religious minorities (Rapporteur: Mr Valeriu Ghiletchi, Republic of Moldova, EPP/CD): authorised the rapporteur to make a fact-finding visit to the United Kingdom;
- Ending cyber-discrimination and online hate (Rapporteur: Ms Marit Maij, Netherlands, SOC): postponed this item to its next meeting;
- Appointment of representatives: appointed (subject to availability of funds):
 - Ms Snežana Jonica (Montenegro, SOC) in her capacity as Chairperson of the Sub-Committee on Disability and Inclusion to participate in the International Expert Level Conference on 22 March 2016 in Sofia (Bulgaria);
