Synopsis of the meeting held in a hybrid manner on 24 and 25 January 2022

The Committee on Equality and Non-Discrimination, meeting in Strasbourg and by videoconference, on 24 and 25 January 2022, with first Mr Jean-Pierre Grin (Switzerland, ALDE), oldest member present, then with Ms Annicka Engblom (Sweden, EPP/CD), Chairperson, in the Chair:

- **Monday 24 January, from 2.30 to 3.30pm**, as regards:
 - **Election of the Bureau of the Committee:** elected by acclamation:
 - Ms Annicka Engblom (Sweden EPP/CD), as Chairperson;
 - Ms Béatrice Fresko-Rolfo (Monaco, ALDE), as First Vice-Chairperson;
 - Mr Momodou Malcolm Jallow (Sweden, UEL), as Second Vice-Chairperson;
 - Mr Fourat Ben Chikha (Belgium, SOC), as Third Vice-Chairperson;
 - **Combating rising hate against LGBTI people in Europe** (*Rapporteur: Mr Fourat Ben Chikha, Belgium, SOC*): took position on 15 amendments and one oral sub-amendment tabled to the draft resolution and 1 amendment tabled to the draft recommendation and asked its Chairperson to propose that the amendments unanimously approved be declared as adopted by the Assembly under Rule 34.11 of the Assembly's Rules of Procedure;
- **Tuesday 25 January, from 2 to 3.30pm**, as regards:
 - **Stopping harassment of women and men speaking out for the right to abort** (*Rapporteur: Ms Margreet De Boer, Netherlands, SOC*): decided to change the title of the report to *Access to abortion in Europe: stopping anti-choice harassment*; considered and approved a draft report and unanimously adopted a draft resolution;
 - **Raising awareness of and countering Islamophobia in Europe** (*Rapporteur: Mr Momodou Malcolm Jallow, Sweden, UEL*): considered an information memorandum;
 - **The role of political parties in fostering diversity and inclusion: a new Charter for a non-racist society** (*Rapporteur: Mr Momodou Malcolm Jallow, Sweden, UEL*): considered an introductory memorandum;

- **Appointment of rapporteurs:** appointed:
 - Ms Zita Gurmai (Hungary, SOC), Rapporteur for report on *The Istanbul Convention: progress and challenges*;
 - Ms Zita Gurmai (Hungary, SOC), General Rapporteur on Violence against women;
 - Ms Petra Bayr (Austria, SOC), General Rapporteur on Combating racism and intolerance;
 - Mr Christophe Lacroix (Belgium, SOC), General Rapporteur on the rights of lesbian, gay, bisexual, transgender and intersex (LGBTI) people;

and heard from each of them a declaration of absence of conflict of interests;

- **Sub-Committees:** re-constituted its Sub-Committees on Gender Equality; on the Rights of Minorities; and on Disability, Multiple and Intersectional Discrimination; and approved their composition as set out in appendices 1, 2 and 3;
- **Assembly's institutional representation:** appointed Ms Petra Bayr (Austria, SOC) as representative and Mr Momodou Malcolm Jallow (Sweden, UEL) as substitute to the European Commission against Racism and Intolerance (ECRI) for 2022;
- **Committee representation:** appointed Ms Edite Estrela (Portugal, SOC) as member of the Network of Contact Parliamentarians for a healthy environment;
- **Gender breakdown in Assembly positions in 2021:** heard a communication by the Chairperson and held an exchange of views;
- **Combating antisemitism in Europe** (*Rapporteur: Ms Petra Bayr, Austria, SOC*): considered an introductory memorandum;
- **Appointment of representatives:** appointed (*subject to the availability of funds*):
 - Mr Fourat Ben Chikha (Belgium, SOC) to participate in the preparatory meeting of the Working Group on Sexual Orientation and Gender Identity (GT-ADI-SOGI) to be held on 1 February 2022 by videoconference;
 - Ms Petra Bayr (Austria, SOC) and Mr Jean-Pierre Grin (Switzerland, ALDE) to participate in the 1st meeting of the Committee of experts on Hate Crime of the Council of Europe (PC/ADI-CH) to be held on 16-17 February 2022, in Strasbourg and by videoconference;
- **Václav Havel Human Rights Prize 2022: call for nominations:** took note of the procedure and the deadline of 30 April 2022 for the submission of nominations as well as the relevant information available on the Václav Havel Human Rights Prize website;
- **Next meetings:**
 - confirmed its next meetings as follows:
 - 14 March 2022 (*place and format to be confirmed*);
 - Strasbourg, during the second part-session 2022 of the Assembly (25 to 29 April 2022);
 - 12 May 2022 (*place and format to be confirmed*);
 - Strasbourg, during the third part-session 2022 of the Assembly (20 to 24 June 2022);
 - 16 September 2022 (*place and format to be confirmed*);
 - Strasbourg, during the fourth part-session 2022 of the Assembly (10 to 14 October 2022);
 - 1 December 2022 (*place and format to be confirmed*);
 - approved the holding of a meeting of the Sub-Committee on Gender Equality to participate in a side-event organised during the Committee on the Status of Women (CSW 66) to be held from 14 to 25 March 2022, at a date to be decided (*by videoconference and subject to the availability of funds*).
