Synopsis of the meeting held in Strasbourg on 21 and 23 June 2011

The **Committee on the Environment, Agriculture and Local and Regional Affairs**, meeting in Strasbourg on 21 and 23 June, with Mr Papadimoulis, (Greece, UEL) in the Chair, as regards:

- The role of parliaments in the consolidation and development of social rights in Europe (Rapporteur for opinion: Sir Alan Meale, United Kingdom, SOC): approved unanimously a draft opinion and amendments to the report of the Committee on Social, Health and Family Affairs;

- **Armed conflicts and the environment** (*Rapporteur: Mr Huseynov, Azerbaijan, ALDE*): approved unanimously a draft report and adopted a draft resolution;

- **Reform of the Assembly:** held an exchange of views;
- **Country risks models: role of parliamentarians:** held an exchange of views with participation of:
