## Synopsis of the meeting held in Strasbourg on 4 and 6 October 2011

The Committee on the Environment, Agriculture and Local and Regional Affairs, meeting in Strasbourg on 4 and 6 October 2011, with Mr Papadimoulis, (Greece, UEL) in the Chair, as regards:

- The activities of OECD in 2010-2011 (Committee spokesperson: Mr Papadimoulis, Greece, UEL): unanimously approved a draft contribution by the Committee to the enlarged debate of the Assembly and prepared the debate;
- Preparatory meeting of the Parliamentary Political Process to the 6<sup>th</sup> World Water Forum (Strasbourg, 10 June 2011): held an exchange of views with the participation of Mr Thierry Umbehr, Secretary General, Solidarity Water Europe and decided to prepare a declaration for the next World Water Forum;
- Summit on Climate Change (COP-17 Durban, 28 November 9 December 2011): held an exchange of views and approved a draft declaration;
- The need for independent and credible expert assessments (Rapporteur Mr Preda, Romania, EPP/CD): considered a draft report and a preliminary draft resolution and held an exchange of views;
- The impact of the world economic crisis on local and regional authorities (Rapporteur: Sir Alan Meale, United Kingdom, SOC): heard a presentation of a draft report by the Rapporteur and held an exchange of views;
  - Nanotechnologies, a new danger to the environment? (Rapporteur: Mr Sudarenkov, Russia, SOC): heard a presentation of a preliminary draft report by the Rapporteur and held an exchange of views:
  - **Food security** (Rapporteur: Mrs John-Calame, Switzerland, SOC): heard a presentation of a preliminary draft report by the Rapporteur and held an exchange of views and agreed to hold a hearing on this item during its next meeting;
  - Reply by the Committee of Ministers to Recommendation 1947 on noise and light pollution: took note of the reply;
  - The Foresters' Declaration, adopted in Sibiu (Romania) on 25 August 2011: took note of the declaration;
