Synopsis of the meetings held in Strasbourg from 2 to 5 October 2006

The Committee on Legal Affairs and Human Rights, meeting in Strasbourg

- on 2 October 2006 at 14 h, with Mr Marty (Switzerland, ALDE) in the Chair, as regards:
- Implementation of judgments of the European Court of Human Rights (Rapporteur: Mr Jurgens, Netherlands, SOC): took position on the amendment tabled to the draft resolution;
- Europe's interest in the continued economic development of Russia (Rapporteur: Mrs Leutheusser-Schnarrenberger, Germany, EPP/CD): considered a report tabled by the Committee on Economic Affairs and Development, approved an opinion and six amendments to the draft recommendation, and asked its Rapporteur to present them to the Plenary Assembly.

- on 3 October 2006 at 8 h 30, with Mr Marty (Switzerland, ALDE) in the Chair, as regards:
- Alleged secret detentions and unlawful inter-state transfers of detainees involving Council of Europe member states (Rapporteur: Mr Marty, Switzerland, ALDE): held an exchange of views with the President of the Assembly, took note of a joint Declaration by the President of the Assembly and the Rapporteur and asked the Rapporteur to go to Guantanamo Bay [subject to the authorisation of the Bureau];
- Video surveillance of public areas (Rapporteur: Mr Sharandin, Russia, EDG):
 - held an exchange of views with Mr Paul Wille, Belgian Senator and Member of the Assembly
 - considered an introductory memorandum
 - decided to ask the Venice Commission to prepare an opinion on the question
 - decided, in view of the above, to ask the Bureau to prolong the Rapporteur's mandate;

- **The rights of national minorities in Latvia** (Rapporteur: Mr Severin, Romania, SOC): after a preliminary general discussion, decided to postpone consideration of the draft report until the next meeting of the Committee;

 - heard a report by the Chairperson of the Sub-Committee on the meeting held in Strasbourg on 4 October 2006
 - took note that a motion was to be tabled with a view to amending paragraph 3.ii of Resolution 1366 (2004), as amended by Resolution 1426 (2005)
 - if the motion was tabled, asked its Chairperson to write to the President of the Assembly asking that the Committee be seized for report
 - in anticipation of this, appointed Mrs Bemelmans-Videc (Netherlands, EPP/CD) Rapporteur
 - took note of the appointment of Mr Holovaty (Ukraine, ALDE) as a titular member of the Sub-Committee, replacing Mr Masi (San Marino, ALDE);
- **Sub-Committee on Human Rights** (Chairperson: Mr Pourgourides, Cyprus, EPP/CD): in the absence of the Sub-Committee's Chairperson, heard a report by Mr Marty on the meeting held in Strasbourg on 4 October 2006;
- Composition of the Sub-Committee on Rights of Minorities (Chairperson: Mr Cilevics, Latvia, SOC): took note of the appointment of Mr Ivan Popescu (Ukraine, SOC) as a member;
- Fair trial issues in criminal cases concerning espionage or divulging state secrets (Rapporteur: Mr Pourgourides, Cyprus, EPP/CD): confirmed its decision to request that this report be presented at a plenary session and asked its Chairperson to inform the Bureau accordingly;
- The United States of America and international Law (Rapporteur: Mr Lloyd, United Kingdom, SOC): decided to invite an expert, Mr Philippe Sands, for a exchange of views with the Committee at its meeting in Paris on 6 November 2006;

- Access to medical treatment for former Minister of Economic Development Farhad Aliyev (Azerbaijan): considered the reply received and information presented by the Chairperson of the parliamentary delegation of Azerbaijan and invited him to ask his authorities if they would be prepared to allow Mr Aliyev's family to send for a foreign doctor of their choice to come and examine Mr Aliyev, at their own cost;
- **Alleged summary execution in Ingushetia and secret prison in Grozny:** invited the Chairperson to ask the Russian authorities and the NGO "Memorial" for additional information;
- **Alleged harassment of human rights defenders in Serbia:** asked its Chairperson to get more information on this matter from the Chairperson of the Serbian parliamentary delegation;
- **Next meeting:** left it to the Chairperson to fix the date and place of the next meeting.
