# To the members of the Committee on Legal Affairs and Human Rights

# Synopsis of the meeting held in Bern on 5 September 2022<sup>1</sup>

**The Committee on Legal Affairs and Human Rights**, meeting in Bern on 5 September 2022, with Mr Damien Cottier (Switzerland, ALDE) in the Chair, as regards:

- Welcoming address: heard a welcoming address and interventions by the President of the Council of States, Mr Thomas Hefti (Swiss Parliament), and Mr Damien Cottier, Chairperson of the Swiss delegation to the Parliamentary Assembly;
- Mission report of the ad hoc sub-committee of the Committee on Legal Affairs and Human Rights to the Committee on Legal Affairs and Human Rights on carrying out a fact-finding visit to Ukraine for the purpose of gathering information on possible war crimes and crimes against humanity committed during the war of aggression launched by the Russian Federation against Ukraine: held an exchange of views and decided to declassify the misson report; agreed to take the mission report into consideration for the future report on "Legal and human rights aspects of the Russian Federation's aggression against Ukraine" (Rapporteur: Mr Damien Cottier, Switzerland, ALDE);
- Preventing vaccine discrimination (Rapporteur: Ms Thórhildur Sunna Ævarsdóttir, Iceland, SOC) : considered a draft report and unanimously adopted a draft resolution and a draft recommendation;
- The impact of the Covid-19 restrictions for civil society space and activities (Rapporteur: Ms Margreet De Boer, Netherlands, SOC): considered a draft report and unanimously adopted a draft resolution and a draft recommendation;
