Synopsis of the meeting held in Strasbourg on 26 January 2021 from 2:00pm to 3:30pm

The Committee on Migration, Refugees and Displaced Persons, meeting in hybrid mode in Strasbourg, with Lord Leslie Griffiths (United Kingdom, SOC), oldest member present, and then Mr Pierre-Alain Fridez (Switzerland, SOC) in the Chair:

- **Election of the Bureau of the Committee:** elected by acclamation:
 - Mr Pierre-Alain Fridez (Switzerland, SOC), Chairperson;

- **Reconstitution of Sub-Committees:** reconstituted its three sub-committees and approved their composition¹:

- **For a European policy on diasporas** (*Rapporteur: Mr Paulo Pisco, Portugal, SOC*): considered the draft report and the preliminary draft resolution and recommendation and asked parliaments to respond to the questionnaire if their parliaments had not already done so;

 - Was informed by the chair on the progress in launching the Parliamentary campaign to prevent migrant children going missing and invited member states to provide financial support to the campaign. Decided to return to the issue at the next meeting of the Committee and also examine further the proposal of Ms Serap YAŞAR (Turkey, NR) to create a post of General Rapporteur on missing migrant children in Europe;
