**The Committee on the Honouring of Obligations and Commitments by Member States of the Council of Europe**, meeting in Strasbourg on 23, 24 and 26 September with Mrs Durrieu in the Chair:

- *Functioning of democratic institutions in Moldova (co-rapporteurs: Mrs Durrieu, France, SOC, and Mr Vahre, Estonia, EPP/CD)*: heard a statement by the co-rapporteurs on their fact-finding visit to the country on 11 and 12 September 2002, approved a draft report, adopted a preliminary draft resolution with a view to presenting them to the Assembly at its present Part-Session, and then took position on five amendments tabled to the draft resolution;
- *Armenia (co-rapporteurs: Mrs Belohorská, Slovakia, EDG, and Mr Jaskiernia, Poland, SOC)*: took position on 15 amendments tabled to the draft resolution;
- *Azerbaijan (co-rapporteurs: Mr Gross, Switzerland, SOC, and Mr Martinez Casañ, Spain, EPP/CD)*: took position on 28 amendments tabled to the draft resolution;
- *Ukraine (co-rapporteurs: Mrs Severinsen, Denmark, LDR, and Mrs Wohlwend, Liechtenstein, EPP/CD)*: authorised the co-rapporteurs to carry out a fact-finding visit to the country on 13-16 October 2002;
- *Albania (co-rapporteurs: MM. Smorawinski, Poland, EPP/CD, and Soendergaard, Denmark, UEL)*: authorised the co-rapporteurs to carry out a fact-finding visit to the country on 11-15 November 2002;
- appointed Mr Frunda (Romania, EPP/CD) to participate in the third meeting of the Council for Democratic Elections of the European Commission for Democracy through Law (Venice, 16 October 2002);
- *Next meetings*:

  - . in Paris, on 11 December 2002.
