**The Committee on the Honouring of Obligations and Commitments by Member States of the Council of Europe**, meeting in Paris on 7 June 2007 with Mr Lintner (Germany, EPP/CD) in the Chair:

as regards:

- *Monaco* (Co-rapporteurs: Mr Agramunt, Spain, EPP/CD and Mr Slutsky, Russia, SOC): approved a draft report, amended and adopted a draft resolution on the honouring of obligations and commitments by Monaco;
- *Ukraine* (Co-rapporteurs: Mrs Severinsen, Denmark, ALDE and Mrs Wohlwend, Liechtenstein, EPP/CD): heard a statement by Mrs Severinsen on the current situation and decided to examine further developments in Ukraine at its next meeting;
- *Armenia* (Co-rapporteurs: Mr Colombier, France, EPP/CD and Mr Mimica, Croatia, SOC): heard a statement by the co-rapporteurs on the parliamentary elections (12 May 2007);
- *European Commission for the Efficiency of Justice*: held an exchange of views with Mr Fausto de Santis, President of the CEPEJ;
- *Follow-up of the debate on the "State of Human Rights and democracy in Europe"*: held an exchange of views;
- *Next meetings*: decided to hold its next meetings as follows:
  - in Strasbourg during the 3<sup>rd</sup> part of the 2007 session (25-29 June 2007)
  - in Paris, on 12 September 2007 (*to be confirmed*)
  - in Strasbourg during the 4<sup>th</sup> part of the 2007 session (1-5 October 2007)
