The Committee on the Honouring of Obligations and Commitments by Member States of the Council of Europe (Monitoring Committee), meeting in Paris on 18 November 2009, with Mr Holovaty (Ukraine, ALDE) in the Chair:

as regards:

– *Exchange of views with the Chairpersons of three Council of Europe human rights monitoring mechanisms*: heard statements on the rights of persons belonging to vulnerable groups in the light of the recent financial crisis by:

- . Mrs Polonca Končar, President of the European Committee of Social Rights;
- . Mr Alan Phillips, President of the Advisory Committee of the Framework Convention for the Protection of National Minorities;
- . Mr Nils Muiznieks, Vice-Chair of the European Commission against Racism and Intolerance.

held an exchange of views on ways and means to improve synergies between these mechanisms and the Monitoring Committee, identified a number of specific issues regarding the rights of persons belonging to vulnerable groups to which the Monitoring Committee's co-rapporteurs could pay particular attention and decided to exchange information on these issues with the three mechanisms on a regular basis;

– *Montenegro* (co-rapporteurs: Mr Gardetto, Monaco, EPP/CD, and Mr Holovaty, Ukraine, ALDE): considered a preliminary draft report on the honouring of obligations and commitments by Montenegro and decided to transmit it to the Montenegrin delegation for comments, within a maximum of three months;

– *Azerbaijan* (co-rapporteurs: Mr Herkel, Estonia, EPP/CD, and ...): appointed Mr Debono Grech (Malta, SOC) co-rapporteur to replace Mrs Jivkova;

– *Albania* (co-rapporteurs: Mr Laakso, Finland, UEL, and Mr Wilshire, United Kingdom, EDG): heard a statement by the co-rapporteurs on their fact-finding visit to Albania (3-5 November 2009) and asked them to prepare a draft report on "*The functioning of democratic institutions in Albania*" for the December 2009 meeting of the Committee, with a view to an Assembly debate at the January 2010 part-session;

– *Ukraine* (co-rapporteurs: Mrs Leutheusser-Schnarrenberger, Germany, ALDE, and Mrs Wohlwend, Liechtenstein, EPP/CD): took note that the fact-finding visit of the co-rapporteurs had been postponed to 6 to 9 December 2009 and decided to return to this issue at its next meeting in December 2009;

– *Term of office of co-rapporteurs of the Monitoring Committee* (rapporteur: Mr Agramunt, Spain, EPP/CD): took note of the outline of the draft report presented by the rapporteur and invited him to present his draft report for adoption at one of its next meetings, with a view to a debate at the Standing Committee in March 2010;

– *Follow-up to be given by the Committee to the decisions taken by the Bureau of the Assembly:*

i. held an exchange of views with members of the Georgian and Russian delegations on the follow-up given to Resolution 1683 (2009) on “*The war between Georgia and Russia: one year after*”, asked the Georgian and Russian delegations to provide the Committee with written information on the implementation of Resolution 1683 (2009) by 15 January 2010 at the latest, with a view to holding an exchange of views during the January 2010 part-session, and decided to prepare a report on the follow-up given to Resolution 1683 (2009) with a view to an Assembly debate during the April 2010 part-session;

ii. instructed its Chairman to inform the Bureau of the Assembly that the implementation of paragraph 8 of Resolution 1687 (2009) on the “*Reconsideration on substantial grounds of the previously ratified credentials of the Russian delegation (Rule 9 of the Rules of Procedure of the Assembly)*” would be the task of the co-rapporteurs with respect to Russia’s monitoring to be appointed in January 2010;

– *Future appointment of co-rapporteurs:* in the light of the changes to the national delegations and the composition of the Committee which will take place at the opening of the January 2010 part-session, decided to consider the appointment of co-rapporteurs on any vacant seats, at its meeting during the January 2010 part-session;

– *Next meeting:* decided to hold its next meeting on 17 December 2009 in Paris.
