Synopsis of the meetings held by videoconference on 25 March 2021

The Committee on Rules of Procedure, Immunities and Institutional Affairs, meeting by videoconference on 25 March 2021, with Ms Ingjerd Schou (Norway, EPP/CD) in the Chair, as regards:

- **Gender representation in the Parliamentary Assembly** (*Rapporteur: Ms Nicole Trisse, France, ALDE*): heard a statement by the rapporteur and, following an exchange of views, decided to hold a joint hearing with the Committee on Equality and Non-Discrimination at its meeting on 2 June 2021;

- Budget and priorities of the Council of Europe for the period 2022-2025 and Expenditure of the **Parliamentary Assembly for the period 2022-2025** (General rapporteur: Mr Tiny Kox, Netherlands, UEL): hold an exchange of views with Ms Marija Pejčinović Burić, Secretary General of the Council of Europe, heard a statement by the rapporteur and invited him to present two draft reports for adoption at the next meeting;

- Guidelines on the scope of the parliamentary immunities enjoyed by members of the **Parliamentary Assembly** (Rapporteur: Mr Tiny Kox, Netherlands, UEL): heard a statement by the rapporteur and invited him to present a preliminary draft report at its next meeting;

- **Respect of the rule of law and fight against corruption within the Council of Europe** (*Rapporteur: Mr Frank Schwabe, Germany, SOC*): heard a statement by the rapporteur and decided to hold a hearing at a next meeting;

- (in camera) Alleged breaches of the Code of conduct for members of the Parliamentary Assembly: in accordance with the Assembly's rules and the committee's procedure:

• Complaint concerning Mr Oleksii Goncharenko (Ukraine, EC/DA): at his request and having taken note of his unavailability, decided to postpone the hearing of Mr Goncharenko to its next meeting;

• Complaints concerning a letter sent by Mr Ian Liddell-Grainger (United Kingdom, EC/DA) to the President of the Assembly on 12 February 2021: held a preliminary exchange of views and decided to proceed to the hearing of two members of the Assembly at its next meeting ;

- Work programme: took note of the work programme;

- **Other business:** took note of a letter from Mr Andreas Nick, Chairperson of the German parliamentary delegation, informing the committee of the waiver of the parliamentary immunity of Mr Axel Fischer, Member of the Bundestag, former member of the Assembly;
