 - .Fighting "child sex tourism" through committed legal and political action (Rapporteur : Mr Omtzigt, Netherlands, EPP/CD): in the absence of the rapporteur, considered an outline report and held an exchange of views with the participation of Jasmina Byrne, Child Protection Specialist, UNICEF Innocenti Research Centre (IRC);
 - . Independent human rights institutions for children: their contribution to Building a Europe for and with Children: held an exchange of views with the participation of Vanessa Sedletzki, Child Rights Specialist, UNICEF Innocenti Research Centre (IRC);
- Psychological violence (Rapporteur: Ms Rupprecht, Germany, SOC): considered, amended and approved unanimously a draft opionion as amended;
- Decent pensions for all following the economic and financial crisis (Rapporteur: Mr Jacquat, France, EPP/CD): considered an introductory memorandum;
- What Europe can do for children in the aftermath of natural disasters and crisis situations: the examples of Haiti and Afghanistan (Rapporteur: Ms Hostalier, France, EPP/CD): unanimously approved the amendments submitted by the Committee on Migration, Refugees and Population:
- The impact of increasing social exclusion on democratic institutions and participation: need for strong action (Rapporteur: Ms Kaufer, Hungary, SOC): heard a statement by the rapporteur and held an exchange of views with Mr Bálint Misetics, consultant expert;
- Austerity measures a danger for democracy and social rights (Rapporteur: Mr Hunko, Germany, UEL): considered an outline report;
- Committee's work programme:
 - held an exchange of views on "Living together in 21st-century Europe: follow-up to the report of the Group of Eminent Persons of the Council of Europe" and approved the proposals of the Chairperson;
 - ✓ held an exchange of views on the contribution by the current Social, Health and Family Affairs Committee to the priorities of the new Social, Health and Sustainable Development Committee in 2012, and approved proposals to be made to the New Committee:
