

**The Committee on Social Affairs, Health and Sustainable Development**, meeting in Paris on Thursday, 22 March 2012, with Ms Maury Pasquier (Switzerland, SOC) in the Chair:

As regards:

- Decent pensions for all (Rapporteur: Mr Jacquat, France, EPP/CD): considered a draft report, agreed to change the title from "Decent pensions for all following the economic and financial crisis" to "Decent pensions for all", amended a preliminary draft resolution and unanimously adopted a draft resolution and a draft recommendation with a view to presenting the report for debate at the April 2012 part-session;

- *Promoting an appropriate policy on tax-havens* (Rapporteur: Mr Van der Maelen, Belgium, SOC): considered a draft report, amended and adopted a draft resolution with a view to presenting the report for debate at the April 2012 part-session;

- *Restoring social justice through a tax on financial transactions* (Rapporteur: Ms Naghdalyan, Armenia, ALDE): in the absence of the Rapporteur, took note of an outline report;

- Towards a Council of Europe Convention to combat trafficking in organs, tissues and cells of human origin (Rapporteur: Mr Marquet, Monaco, ALDE): heard an oral report by Mr Marquet on the state of negotiations in the drafting Committee (PC-TO), whose first two meetings he had attended on behalf of the Committee, considered an outline report, decided to make this outline report and the minutes of the discussion thereon available to the PC-TO, and decided to invite the Chairperson of the PC-TO to one of its meetings during the June 2012 part-session;

- Update on the Council of Europe ONE in FIVE campaign: heard a statement by the Chairperson;
