Synopsis of the meeting held in Strasbourg from 30 September to 3 October 2013

The Committee on Social Affairs, Health and Sustainable Development, meeting in Paris with Ms Liliane Maury Pasquier (Switzerland, SOC), Chairperson, in the Chair, as regards:
