Synopsis of the meeting held in Paris on 14 March 2014

The Committee on Social Affairs, Health and Sustainable Development, meeting in Paris with Mr Valeriu Ghiletchi (Republic of Moldova, EPP/CD), Chairperson, in the Chair, as regards:

- Decent work for all (Rapporteur: Mr Roel Deseyn, Belgium, EPP/CD): considered a draft report and
 unanimously adopted a draft resolution as amended, with a view to presenting the report for debate in the
 Assembly during the April 2014 part-session;
- Ending child poverty in Europe (Rapporteur: Ms Sevinj Fataliyeva, Azerbaijan, EDG): considered a draft report and unanimously adopted a draft resolution and a draft recommendation, with a view to presenting the report for debate in the Assembly during the April 2014 part-session;
- The protection of minors against excesses of sects (Rapporteur for opinion: Mr André Bugnon, Switzerland, ALDE): considered and unanimously approved a draft opinion as amended, including 8 amendments;
- Promotion of social rights: held an exchange of views with Mr Luis Jimena Quesada, Chairperson of the European Committee of Social Rights, and decided that its Sub-Committee on the European Social Charter should participate in the upcoming high-level conference on the European Social Charter to be held in Turin (Italy), on 17-18 October 2014 (subject to Bureau authorisation);
- Committee's work programme and priorities: considered and approved priorities and working structures for the Committee for 2014, including the proposal to put on hold the General Rapporteurship on Local and Regional Authorities;
- Reform of the Assembly: two-year review: held an exchange of views on the questionnaire appended
 to a letter sent to Committee Chairs by the Rapporteur of the Committee on Rules of Procedure,
 Immunities and Institutional Affairs, Ms Liliana Palihovici (Republic of Moldova, EPP/CD), and agreed on
 a draft reply to be sent to this questionnaire;
- Challenges for the Council of Europe Development Bank (Rapporteur: Mr Tuur Elzinga, the Netherlands, UEL): held an exchange of views with Mr Rolf Wenzel, Governor of the Council of Europe Development Bank (CEB), and considered an introductory memorandum;
- Ensuring children with attention problems are properly cared for (Rapporteur: Ms Sílvia Eloïsa Bonet Perot, Andorra, SOC): held an exchange of views on the basis of an outline report with the participation of Dr Chiara Servili, Department of Mental Health of the World Health Organization (WHO);
- Child friendly justice / Children in detention (Rapporteur: Mr Stefan Schennach, Austria, SOC): considered an introductory memorandum and decided to change the title to "Child-friendly juvenile justice: from rhetoric to reality";

Transmission of motions for consultation on the follow-up to be given: considered the motion entitled "Europe must be based on economically viable regions - Effective local self-government for member States", as well as the written declaration submitted to the Committee by Mr Cezar Preda (Romania, EPP/CD) and Mr Marian Neacşu (Romania, SOC) on the matter and decided to propose, to the Bureau, that no follow-up should be given to this motion;

appointed rapporteurs as follows:

. Combating sexual violence against children: towards a successful conclusion of the ONE in FIVE campaign (for report): Mr Valeriu Ghiletchi (Republic of Moldova, EPP/CD), exceptionally appointed in his capacity as Chairperson in view of the urgency of this matter;

and heard from him a declaration on the absence of a conflict of interest;

- . Improving children's access to child-friendly health and social services (for report): Ms Stella Kyriakides (Cyprus, EPP/CD);
- . Freedom of religion and religious practices (for opinion): Ms Liliane Maury Pasquier (Switzerland, SOC);
