# Synopsis of the meeting held in Strasbourg from 8 to 10 April 2014

The Committee on Social Affairs, Health and Sustainable Development, meeting in Strasbourg:

- on Tuesday, 8 April 2014 at 8.30 am, with Mr Valeriu Ghiletchi (Republic of Moldova, EPP/CD), Chairperson, in the Chair, as regards:
- Work of the Council of Europe Commissioner for human rights, Nils Muižnieks: held an
  exchange of views with the Commissioner for human rights on "Safeguarding human rights in times of
  economic crisis":
- Measuring and fostering the well-being of European citizens (Rapporteur: The Earl of Dundee, United Kingdom, EDG): considered a draft report and unanimously adopted a draft resolution with a view to presenting the report for debate in the Standing Committee on 23 May 2014 or in the Assembly during the June 2014 part-session;
- Social services in Europe: legislation and practice of the removal of children from their families in Council of Europe member States (Rapporteur: Ms Olga Borzova, Russian Federation, EDG): heard a report by the rapporteur on her fact-finding visit to the United Kingdom on 10 and 11 February 2014;
- The inclusion of children's rights in national constitutions as an essential component of
  effective national child policies (Rapporteur: Mr Cezar Preda, Romania, EPP/CD): heard a
  presentation on the work of the Venice Commission in this field by Ms Herdis Thorgeirsdottir,
  Vice-President of the Venice Commission:
- on Tuesday, 8 April 2014 at 2 pm, under the chairmanship of Mr Valeriu Ghiletchi (Republic of Moldova, EPP/CD), Chairperson of the Committee on Social Affairs, Health and Sustainable Development, and of Mr Thierry Mariani (France, EPP/CD), Chairperson of the Committee on Migration, Refugees and Displaced Persons, as regards:
- 17<sup>th</sup> meeting of the PACE Network of Contact Parliamentarians to stop sexual violence against children and joint meeting with the Committee on Migration, Refugees and Displaced Persons:
  - heard a statement by Ms Gabriella Battaini-Dragoni, Deputy Secretary General of the Council of Europe, concerning the Council of Europe ONE in FIVE Campaign;

- Optimum care for women with breast cancer (Rapporteur: Ms Stella Kyriakides, Cyprus, EPP/CD):
   considered an introductory memorandum, modified the title to read "Towards optimum breast cancer
   services across Europe" and held an exchange of views with the participation of:
  - Dr Alberto Costa, Scientific Director and CEO, European School of Oncology;
  - Dr Nereo Segnan, Head of Department of Cancer Screening and Unit of Cancer Epidemiology, University Hospital "Città della Salute e della Scienza", Turin, Italy;
- Combating sexual violence against children: towards a successful conclusion of the ONE in FIVE Campaign (Rapporteur: Mr Valeriu Ghiletchi, Republic of Moldova, EPP/CD): considered a draft report and unanimously adopted a draft recommendation as amended, with a view to presenting the report for debate in the Standing Committee on 23 May 2014;
- Children's right to physical integrity: took note of the reply by the Committee of Ministers to the Assembly's Recommendation 2023 (2013);
- on Thursday, 10 April 2014, at 2 pm, under the chairmanship of Mr Valeriu Ghiletchi (Republic of Moldova, EPP/CD), Chairperson of the Committee on Social Affairs, Health and Sustainable Development, and of Mr James Clappison (United Kingdom, EDG), Chairperson of the Committee on Legal Affairs and Human Rights, as regards:
- Joint hearing with the Committee on Legal Affairs and Human Rights on "Removal of children from their families: legislation and practice" (Rapporteur: Ms Olga Borzova, Russian Federation, EDG): held an exchange of views with the participation of:
  - Ms Maria Herczog, Rapporteur of the United Nations Committee on the Rights of the Child (UNCRC) (Hungary);
  - Ms Karen Reid, Registrar of the Filtering Section, European Court of Human Rights;
