Synopsis of the meeting held in Strasbourg on 18-21 April 2016

The Committee on Social Affairs, Health and Sustainable Development, meeting in Strasbourg:

- Monday, 18 April 2016, at 1.45 pm, with Ms Stella Kyriakides (Cyprus, EPP/CD) in the chair, as regards:
- Preventing the radicalisation of children by fighting the root causes (Rapporteur: Ms Sevinj Fataliyeva, Azerbaijan, EC): considered and unanimously approved an addendum to the report and 3 amendments to be tabled on behalf of the Committee;
- Monday, 18 April 2016, at 2 pm, in a joint meeting with the Committee on Migration, Refugees and Displaced Persons: held a hearing on "Missing unaccompanied migrant children" with the participation of:
 - . Mr Jean-Claude Legrand, Regional Adviser for Child Protection, UNICEF, Geneva (Switzerland);
 - . Ms Federica Toscano, Project Officer, Focal Point on Missing Unaccompanied Children, Missing Children Europe NGO, Brussels (Belgium);
 - . Mr Gert Westerveen, Representative of the United Nations High Commissioner for Refugees to the Strasbourg-based European Institutions, Strasbourg (France);
- Tuesday, 19 April 2016, at 2 pm with Ms Stella Kyriakides (Cyprus, EPP/CD), Chairperson, in the Chair, as regards:
- Election of the 2nd Vice-Chairperson: elected by acclamation Ms Vasiliki Katrivanou, Greece, UEL;

- 26th meeting of the PACE Network of Contact Parliamentarians to stop sexual violence against children: heard an exchange of views on "Presentation of the Cyprus pilot project: an example of good practice" with the participation of:
 - . Mr Anastasios Paul Leventis, Chairman of the Board of the A.G. Leventis Foundation;
 - . Ms Anastasia Papadopoulos, expert appointed by the Council of Ministers of Cyprus to compile a National Strategy and member of the project Steering Group;

- Increased income inequalities are a threat to social cohesion (*Rapporteur: Mr Tuur Elzinga, Netherlands, UEL*): considered an introductory memorandum;
