### **Revised synopsis** of the meeting held in Florence from 30 November to 1<sup>st</sup> December 2016

**The Committee on Social Affairs, Health and Sustainable Development,** meeting in Florence with Ms Sílvia Eloïsa Bonet (Andorra, SOC), first Vice-Chairperson, and (for the item "Drafting social indicators and issuing an annual report on social rights / The "Turin process" for the European Social Charter")

Mr Ögmundur Jónasson (Iceland, UEL), second Vice-Chairperson, in the Chair:

- Wednesday, 30 November 2016, as regards:
- Issues related to children's rights and to current reports of the Committee: heard statements by Ms Sarah Cook, Director, on the Research for Children at UNICEF Office of Research Innocenti, and Ms Alessandra Maggi, President of the Istituto degli Innocenti, and held an exchange of views with:
  - ✓ Ms Abir Abi-Khalil, Child Protection Specialist, on drivers of violence affecting children;
  - ✓ Ms Jasmina Byrne, Child Protection Specialist and Mr Daniel Kardefelt Winther, Child Protection Consultant, on children's use of the internet - risks and opportunities;
  - Mr Dominic Richardson, Senior Education Specialist, on the Innocenti Report Card on child wellbeing in EU / OECD countries;
- Protecting children and young people affected by armed conflicts (Rapporteur: Ms Sevinj Fataliyeva, Azerbaijan, EC): considered an introductory memorandum and agreed to change the title to "Protecting children affected by armed conflicts";
- Sub-Committee on the European Social Charter: heard a report by the Sub-Committee Chairperson on its meeting held in Paris on 28 October 2016, hosting the Parliamentary Seminar on "The right of children and young people to social, legal and economic protection";
- Genetically engineered human beings (Rapporteur: Ms Petra De Sutter, Belgium, SOC): considered a preliminary draft report and agreed to change the title to "The use of new genetic technologies in human beings";
- A European social commitment guaranteeing the rights of older people and their comprehensive care (Rapporteur: Lord George Foulkes, United Kingdom, SOC): considered a preliminary draft report and agreed to change the French title to "Garantir les droits des personnes âgées et leur prise en charge intégrale : un engagement social européen";

#### – Committee's work programme:

- Addressing forced marriage: legal provisions and promising practices: appointed Ms Maryvonne Blondin (France, SOC) rapporteur (for opinion)

and heard from her a declaration on the absence of a conflict of interests, as well as from Lord John Prescott as regards the report "Climate change and implementation of the Paris Agreement" for which he had been appointed rapporteur at a previous meeting;

- The Charter of Milan: food as a fundamental human right: took note of this motion which had been sent to it for information and decided to come back to the question at one of its next meetings;
- Recommendation 2091 (2016) "The case against a Council of Europe legal instrument on involuntary measures in psychiatry": postponed the consideration of the reply of the Committee of Ministers to one of its next meetings in the absence of the Rapporteur;

- Reinforcing social dialogue as an instrument for stability and decreasing social and economic inequalities (Rapporteur: Mr Ögmundur Jónasson, Iceland, UEL): considered a draft report and unanimously (with one abstention) adopted a draft resolution, with a view to presenting the report for debate in the Assembly during the first part-session 2017;
- The need for a citizenship income (Rapporteur: Ms Nunzia Catalfo, Italy, NR): heard a statement by the Rapporteur on her fact-finding visit to Finland;

### Appendix

### Florence declaration, 1 December 2016

### Adopted by the Network of Contact Parliamentarians to stop sexual violence against children of the Parliamentary Assembly

We, the members of the Network, convened at our 27<sup>th</sup> and final meeting held at the UNICEF Office of Research *Innocenti* in Florence (Italy), on the theme of "sexual violence against children in the digital environment",

- Aware of the continuous need to support children who have been victims of sexual abuse and sexual exploitation, to prevent any form of sexual violence against children - which we consider as the most serious violation of children's human rights - to prosecute the perpetrators, and establish effective policies and take appropriate action;
- ii) Aware of the fact that the digital environment, including social media, and their active use by children, make it easier for offenders to reach out to children and create ever new forms of abuse of children which are difficult to tackle (grooming, child abuse images, etc.);
- iii) Upholding the Council of Europe Convention on the Protection of Children against Sexual Exploitation and Sexual Abuse ("Lanzarote Convention") as the most comprehensive legal instrument in this field worldwide, and recommending that not only all Council of Europe member States, but all countries in the world sign, ratify and implement it;

#### Undertake to:

- iv) Promote sound legislative frameworks, based on the Lanzarote Convention, in our respective countries, to outlaw any form of sexual violence against children including in the digital environment and improve the collection of specific data to allow for the development of targeted policies with a victim-centred approach;
- v) Ensure that parents, families and professionals working with children receive support in providing positive education empowering children against sexual violence, including in the digital environment, thus enhancing their physical and psychological wellbeing;
- vi) Continue to promote the aims and values of the Council of Europe ONE in FIVE Campaign to combat sexual violence against children (2011-2015) at local, national, and international level;
- vii) Promote multi-stakeholder co-operation involving public authorities at various levels, law enforcement agencies, industry and civil society organisations;
- viii) In our respective parliaments and constituencies, initiate or contribute to specific and thematic awareness-raising and prevention activities, including every year on 18 November, to mark the European Day on the Protection of Children against Sexual Exploitation and Sexual Abuse;
- Take initiatives within our respective parliaments to ensure that national budgets provide for the funding of relevant activities, including voluntary contributions to the new Assembly project "Promoting European and international standards through parliamentary action – parliaments and social rights" (2017-2021);
- x) In all these undertakings, continue to promote an open debate on the protection of children against sexual violence and the imperative to support victims, overcoming persisting taboos and avoiding the stigmatisation of survivors.
