# Synopsis of the meeting held in Strasbourg on 27 and 29 June 2017

The Committee on Social Affairs, Health and Sustainable Development, meeting in Strasbourg:

- Tuesday, 27 June 2017, at 2 pm with Ms Stella Kyriakides (Cyprus, EPP/CD), Chairperson, in the Chair, as regards:
- Freedom of choice and personal lifestyle (Mr Axel Fischer, Germany, EPP/CD): considered an introductory memorandum in the absence of the rapporteur;
- Cross-border parental responsibility conflicts (Rapporteur: Ms Martine Mergen, Luxembourg, EPP/CD): heard a statement by the rapporteur on her fact-finding visit to Paris;
- Committee's work programme and priorities:
  - appointed rapporteurs as follows:
    - Organ transplant tourism (for report): Ms Liliane Maury Pasquier (Switzerland, SOC);
    - Protecting the rights of people with psychosocial disabilities with regard to involuntary measures in psychiatry (for report): Ms Reina Bruijn-Wezeman (Netherlands, ALDE);
    - The activities of the Organisation for Economic Co-operation and Development (OECD) (for opinion): Mr Geraint Davies (United Kingdom, SOC) (in his absence);

and heard from the first two a declaration of absence of conflict of interest;

- decided to treat the item on "Protecting children affected by armed conflicts" (Rapporteur: Ms Sevinj Fataliyeva, Azerbaijan, EC), including the issue of a potential conflict of interest of the Rapporteur, in camera at its next meeting in Paris on 19 September 2017;
- Thursday, 29 June 2017, at 2 pm with Ms Stella Kyriakides (Cyprus, EPP/CD), Chairperson, in the Chair, as regards:
- The "Turin process": reinforcing social rights in Europe (Rapporteur: Ms Silvía Eloïsa Bonet, Andorra, SOC): took position on the two amendments to the draft resolution tabled by the Committee on Political Affairs and Democracy;

Sub-Committee on Public Health and Sustainable Development: heard a report from Ms Martine Mergen (Luxembourg, EPP/CD), Chairperson of the Sub-Committee, on the meeting held on 28 June, including on the exchange of views held with representatives of the "Environmental Platform of the Muğla District" (Turkey); instructed the Chairperson to address a letter to the Chairperson of the Turkish delegation to the Parliamentary Assembly of the Council of Europe on the issues raised in this context, and decided to inform the Monitoring Committee accordingly;
