Synopsis of the meeting held in Paris on 20 March 2018

The Committee on Social Affairs, Health and Sustainable Development, meeting in Paris on 20 March 2018, with Mr Stefan Schennach (Austria, SOC), Chairperson, in the Chair, as regards:

- Communication by the Chairperson: heard a statement by the Chairperson concerning the Parliamentary Assembly's expenditure for the 2018 financial year and the implementation of budgetary savings following the decisions of the Bureau and held an exchange of views thereon;
- Climate change and implementation of the Paris Agreement (Rapporteur: Lord John Prescott, United Kingdom, SOC): considered a draft report and unanimously adopted a draft resolution as amended, with a view to presenting the report for debate in the Assembly during the April part-session 2018;
- Drug-resistant tuberculosis in Europe (Rapporteur: Mr Serhii Kiral, Ukraine, EC): considered a draft report and unanimously adopted a draft resolution as amended, with a view to presenting the report for debate in the Assembly during the April part-session 2018; approved the Rapporteur's request to participate (subject to Bureau authorisation and availability of funds) in the United Nations high-level meeting on the fight against tuberculosis to be held in September 2018 in New York;
- Detention of Palestinian minors in Israeli prisons (Rapporteur: Ms Liliane Maury Pasquier, Switzerland, SOC): considered a preliminary draft report and agreed to change the title of the report to "The treatment of Palestinian minors in the Israeli justice system";
- Committee's work programme and priorities:
- heard a statement by the Chairperson on the Committee's priorities in view of the budgetary situation in the Assembly, held an exchange of views, decided to confirm the cancellation of the Committee meeting originally scheduled to be held in Paris on 8 June 2018, and to come back to the question of whether to discontinue work on certain reports at one of its next meetings;
- took note of the Committee of Ministers' reply to the Assembly's Recommendation 2104 (2017) on "Human rights of older persons and their comprehensive care" and of the Committee of Ministers' reply to the Assembly's Recommendation 2115 (2017) on "The use of new genetic technologies in human beings";
- appointed Baroness Doreen Massey (United Kingdom, SOC) rapporteur on "Stepping up cooperation between European initiatives for better child protection against sexual violence" and heard from her a declaration of absence of conflict of interest, as well as from Ms Petra De Sutter who was appointed rapporteur in her absence during the January part-session for "Anonymous donation of gametes: balancing the rights of parents, donors and offspring";
