Synopsis of the meeting held in Strasbourg from 21 to 25 January 2019

The Committee on Social Affairs, Health and Sustainable Development, meeting in Strasbourg:

- Monday, 21 January 2019, at 2 pm, with first Baroness Doreen Massey (United Kingdom, SOC), oldest member present, and then Mr Stefan Schennach (Austria, SOC), elected Chairperson, in the Chair, as regards:
- Election of the Bureau of the Committee: re-elected by acclamation:
 - Mr Stefan Schennach (Austria, SOC), Chairperson;
 - Mr Luís Leite Ramos (Portugal, EPP/CD), first Vice-Chairperson;
 - Ms Carina Ohlsson (Sweden, SOC), second Vice-Chairperson (in her absence);
- Anonymous donation of sperm and oocytes: balancing the rights of parents, donors and children (Ms Petra De Sutter, Belgium, SOC): considered a draft report and unanimously adopted a draft recommendation with a view to presenting the report for debate in the Assembly during the second partsession 2019;
- Addressing the health needs of adolescents in Europe (Rapporteur: Baroness Doreen Massey, United Kingdom, SOC): considered and unanimously approved the four amendments proposed by the Rapporteur and decided to table them on behalf of the Committee;
